Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner Eldridge Ellison and with all voting "Aye" the court divided the Revenue Sharing Check equally between the four commissioner precincts and the Administrative Fund.

After discussion of the Administrative Account and the necessity to pay some bills and upon a motion by Commissioner R. E. Smith, seconded by Commissioner G. W. Russell, Jr. and with all voting "Aye" the court approved Commissioner R. E. Smith, Pct. No. 1 transferring his part of Revenue Sharing money to the Revenue Administrative Account.

WHEREAS, it is found that the District Attorney's office is attempting to upgrade its services by use of funds now available through the Texas Criminal Justice Division of the Governor's office by obtaining a grant therefrom. The county being in favor of such improvement and such grant for use in prosecution; and

WHEREAS, the County heretofore has been contributing, it will now therefore continue in the amounts and in the manner heretofore done, and, as stated in the Grant Application attached to and now a part of this Resolution; and

WHEREAS, the County intends to continue the Project with local funds at its currently funded level when the Criminal Justice Division Grant for said Project expires.

BE IT THEREFORE RESOLVED, that the Commissioners' Court of Sabine County authorizes the County Judge of Sabine County to sign this Resolution favoring continued contribution and to place the same upon the Minutes of the Commissioners' Court of Sabine County.
