Motion by Commissioner G. W. Russell, Jr. seconded by Commissioner Eldridge Ellison and by unanimous vote the court passed an order requesting the Board of County and District Road Indebtedness, State



of Texas, Austin, Texas to credit the Sabine County Lateral Road account with \$19,851.78 which represents the County's share of the Lateral Road Fund as of August 31st. and which is to be used for construction and improvement of Sabine County lateral roads.

Sealed bids were opened that had been advertised for removal of houses on Jail site property. Motion by Commissioner G. W. Russell, Jr. seconded by Commissioner Jimmy Vickers and by unanimous consent the court rejected the bids as being too low.

Motion by Commissioner R. E. Smith seconded by Commissioner G. W. Russell, Jr. and with all voting in favor of the motion Eldridge Ellison and Mrs. Canton were elected to serve on the 1979 Regional Aging Advisory Council Committee.

Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner Jimmy Vickers and by unanimous consent the Court approved the Following Quarterly Report.
