Gayle Leone's resignation was presented to the Court. Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison and with all voting in favor of the motion her resignation was accepted.

Upon recommendation of Minnie Gooch, County and District Clerk motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison and with all voting "Aye" Annette Conner was hired as Deputy County and District Clerk at a salary of _____ per month and to place Sandra Easley in the position previously held by Gayle Leone, being chief deputy.

Bid for County Depository was opened. There was only one bid submitted and it was from First State Bank, Hemphill. Motion by Commissioner Jimmy Vickers seconded by Commissioner R. E. Smith and all voted in favor of the motion, First State Bank of Hemphill was selected as County Depository for Sabine County.

Pat Washburn appeared before the court again seeking an appointment to Constable of Justice Precinct #3. Motion by Commissioner Jimmy Vickers, seconded by Commissioner R. E. Smith and with all voting "Aye" the court refused the appointment.

E. A. Fortenberry appeared before the court about his taxes in the C. C. Rice Subdivision. Motion by Commissioner R. E. Smith, seconded By Commissioner Eldridge Ellison and with all voting in favor, the two story wood frame building which he did not own was taken off.



Mr. Truett Pritchard at the request of Judge Smith appeared and explained the procedure of the Computer System and the tax roll.

Motion by Commissioner R. E. Smith, seconded by Commissioner Jimmy Vickers and with all voting in favor of the motion the bond of Edwin R. York for collection of delinquent taxes was approved.


Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison and with all voting "Aye" Judge Smith and Commissioner Jimmy Vickers was appointed as board member to the Committee of Tri County Community Action.

Motion by Commissioner Jimmy Vickers seconded by Commissioner R. E. Smith and with all voting in favor of the motion the court agreed to go ahead with funding for the District Attorney staff whether or not the other four counties paid.


Motion by Commissioner Jimmy Vickers seconded by Commissioner Eldridge Ellison to pay out of Permanent Improvement the Ambulance Insurance which had already been agreed upon.

Accounts were allowed and made payable.


THERE being no further business, the court adjourned.


