Motion by Commissioner G. W. Russell Jr., seconded by Commissioner Eldridge Ellison and with all voteing in favor the Court directed that the 1.6 miles more or less of road commonly known as the Sabinetown Road be given top priority with the next Farm to Market roads allotted to Sabine County. The Clerk was directed to write a letter to this affect to James R. Crowe and J. L. Beard of Texas Department of Highways and Public Transportation. See Exhibit Marked "A" and attached to these minutes.

Paul E. Fulman and W. A. Lanier presented a petition to court concernig 3½ miles of road which is an extension of FM 2928. Motion by Commissioner G. W. Russell Jr., seconded by Commissioner R. E. Smith to put this in our records and send a copy to State Department of Highways and Public Transportation. Motion carried.

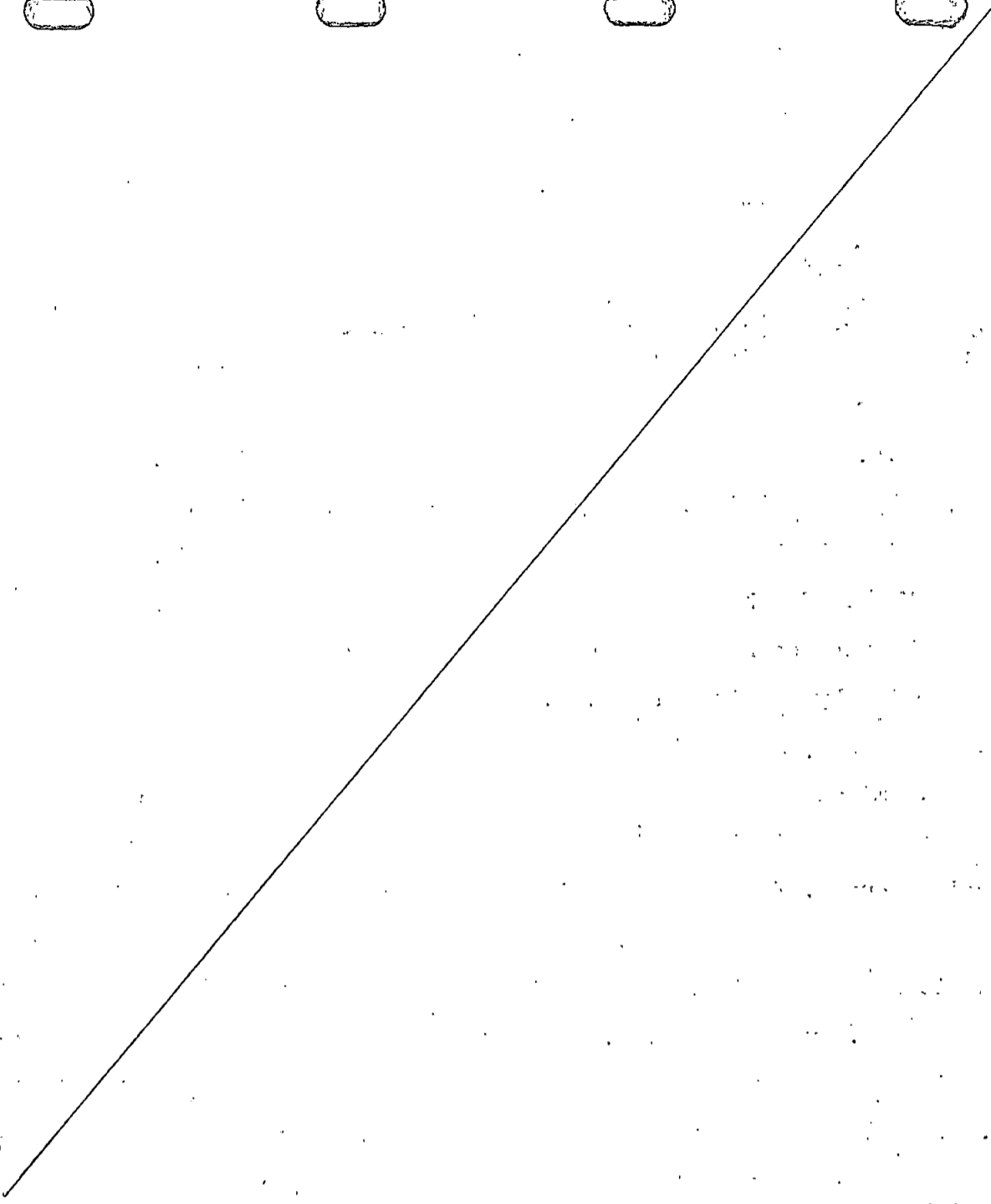
Motion by Commissioner R. E. Smith seconed by Commissioner G. W. Russell Jr. and unanimous consent of the Court a resolution was passed authorizing County Judge to sign on behalf of the County a contract between Texas Department of Community Affairs and County of Sabine.

Motion by Commissioner G. W. Russell Jr., seconed by Commissioner R. E. Smith to re-estate Walter Henry as Custodian. Motion Carried.

Motion by Commissioner G. W. Russell Jr., seconed by Commissioner R.E. Smith that Roberts be paid for work done as Custodian out of General County. Motion Carried.

Motion by Commissioner G. W. Russell seconded by Commissioner Eldridge Ellison and with all voting in favor. The Clerk was directed to write a letter to Congressman Charles Wilson asking that Cable or Chain be removed from across Old Brookeland Road.

THERE being no futher business, the Court adjourned.

PETITION

This Petition is drawn for grieving taxpayers concerned with the condition and maintenance of a Sabine County road that is an extension to FM 2928. This road is approximately 3 1/2 miles long leading to many residences and "Lakeview" National Park. Entrances leading into ~~and~~^{FM 2928} and maintained by county are also mentioned.

After many phone calls by citizens that were getting stuck, sliding in ditches and damaging auto's, met with Commissioners Court on February 12, 1979 to discuss said road. Commissioner G.W. Russell told the citizens that something would be done as soon ^{as} possible. At this writing, March 23, 1979, nothing has been done by the county. One citizen has bought iron ore for one mud hole and the road at present is near impassible with ruts and chug holes 2 feet deep and deeper. Someone is going to be seriously hurt and it is hoped it won't be a child on the school bus. Some citizens that work are getting out by boat to avoid truck damage and there is no way the elderly can get out by car.
