Motion by Commissioner Jimmy Vickers seconded by Commissioner Eldridge Ellison to increase expense for out of county mileage from 16¢ to 20¢ permile. All voted in favor of the motion.

Motion by Commissioner G.W. Russell, Jr. seconded by Commissioner R. E. Smith to reimburse Judge Smith for expense for Deep East Texas Council of Goverments meeting at Pineland for refreshments Bin the amount of \$20.95 and also reimbursement for expense and registeration fee to the Texas Highway Commission meeting in Austin concerning the Tourist Center for Sabine County.

Accounts were allowed and made payable.
