Dr. Joe Mc with MHMR appeared before the court. He explaimed that they have a grant from the Texas Rehabilitation for a workshop, if the county would pledge \$2,500.00. The Work Shop would serve two counties. There will be a mini-bus to take workers to the workshop. The site of the workshop would be determined by the MHMR board of trustees. The workshop would help and give the retarded citizens a chance to work.

Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner R. E. Smith to pledge the \$2,500.00, to be paid in June 1, 1980 when the program is to be in operation. The money is for twelve months, Starting in June 1, 1980.

Mr. Glass appeared before the court concerning the boat ramp at Hide-A-Way Harbor. He explained that there was not a duly authorized Assoc. in Hide-A-Way Harbor to give the boat ramp to.

Commissioner Jimmy Vickers said the court could not give the land for the ramp to any other than a appointed Association of Land Owners. If the lot owners formed a lot owners Assoc. then the county would take action on this matter.

Lynda Melton with Blue Cross-Blue Sheild appeared befor the Court. She explained that the hospitalition policy would cover dental work in case of injury to teeth by accident. She also discussed insurance for workers 65 to 70 years of age.

Ray Melton and Carolyn Drake appeared before the court requesting \$500.00 for the Child Welfare Board, which is needed for the year 1980. Ms Drake also showed the court a breakdown of expenses. Motion by Commissioner R. E. Smith, seconded by Commissioner Jimmy Vickers to grant the money to the board.

All voted in favor. Motion was carried.

Motion by Commissioner Eldridge Ellison, seconded by Commissioner G. W. Russell, Jr. to advertize for bids on a motor graded.

Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner Eldridge Ellison, and by unanimous consent the Court approved the following Quarterly Report.
