Motion by Commissioner R. E. Smith, seconded by Commissioner

G. W. Russell, Jr. to transfer \$5000.00 to each Commissioner Precinct, out of Right of Way Fund, total amount of transfer being \$20,000.00. Motion carried.

Motion by Commissioner G. W. Russell, Jr. seconded by Commissioner Eldridge Ellison to divide the R. & R. Special money in the amount of \$6,207.26 as follows:

22% to R. & B. #1	20% to R. & B. #3
27% to R. & B. #2	31% to R. & B. #4

On recommendation of Richard Bass, Justice of the Peace, Pct. #1 a motion was made by Commissioner G. W. Russell, Jr. seconded by Commissioner Eldridge Ellison to hire Carolyn Woods as secretary for Richard Bass at a salary of \$486.49 effective August 1, 1980.

In order for Sabine County to be eligible for further E.D.A. funds a letter of concurrence accepting document for economic planning is needed. Motion by Commissioner G. W. Russell, Jr. seconded by Commissioner Eldridge Ellison to adopt the following:

Motion by Commissioner R. E. Smith, seconded by Commissioner G. W. Russell, Jr. for Mr. Lank to go ahead and draw up the plan and it will be ready in case the Natural Gas was not hooked up. Motion carried.


Motion by Commissioner R. E. Smith, seconded by Commissioner G. W. Russell, Jr. to pay membership dues in the amount of \$409.35 to DETCOG and membership dues to Deep East Texas Development Association in the amount of \$100.00. All voted in favor of the motion.

Motion by Commissioner R. E. Smith seconded by Commissioner Eldridge Ellison to pay the amount that had been added to the Sheriff Department salaries & expenses by the Corp of Engineers out of Officers Salary Fund with the understanding that it be re-imbursed if Corp of Engineers make other payments this year. All voted in favor.

As requested by letter dated August 20, 1980 and in accordance with Article 3912(k) Section 3, Vernon's Annotated Civil Statutes and upon a motion by Commissioner R. E. Smith seconded by Commissioner G. W. Russell, Jr. the District Court Reporter's Salary was changed to \$239.80 as Sabine County's prerata part effective January 1, 1981. All voted in favor.

Accounts were allowed and made payable.
