On this the 22nd day of September, 1980, The Honorable Commissioners' Court met in regular session with the following members present, to-wit:

The school of instruction for Election Judges and Clerk was brought to the attention of the court. Motion by Commissioner, G. W. Russell, Jr. seconded by Eldridge Ellison to pay the judges and clerk for an hour of their prorato pay, for attending this school. Motion carried.

3 Miss. Floy Dean notified the court that she could not be Election Judge because she had no transportation. She also said Mrs. E. B. Jacks was willing to hold the Election. Motion by Commissioner G. W. Russell, Jr. Seconded by Eldridge Ellison to appoint Mrs. E. B. Jacks as Election Judge for Brookeland Pct. 3. All voted favoring the motion.

Upon a recommendation by Judge Smith and Motion by Commissioner G. W. Russell, Jr. seconded by Commissioner R. E. Smith the court voted unanimously to get Temple Industries, Inc. to make their Pre-Application for HUD Block Grant as a comprehensive Grant. This grant would include more than one item.

The Doc. Field road or the road leading to Earl Smith's property was brought to the attention of the court. Mr. C. B. Counts appeared and said the road had been maintained by the county for many years. He worked for Commissioner Lee Arnold and helped work this road. Mr. Bobby Harris appeared and said it was graded by the county when he traveled it. Earl Smith also appeared and said it had been maintained by the county for many years. Motion by Commissioner Jimmy Vickers seconded by Commissioner G. W. Russell, Jr. and by unanimous consent the court declared the Doc Field or Earl Smith road to be a County Road.

C. C. Stone, M. J. Nelson and Bill Noah, residences of Toledo Villages appeared before the court. They told the court they had filed for a charter to form an Association. They wanted to maintain their roads as well as determine to accessibility into the subdivision. County Attorney James Allen Payne was questioned concerning this matter and will check into it and asked them to return next court day.

The Sabine County Tax Appraisal District sent their budget request for September 1, 1980 to December 31, 1980 in the amount of \$1575.48. Motion by Commissioner R. E. Smith seconded by Commissioner G. W. Russell Jr. the court voted unanimously to pay this in four payments of \$393.87. The Budget request for 1981 will be considered with all requests.

Judge Smith asked for authority to advertise for bids to fix restroom stalls on the first floor for the handicapped. Motion by Commissioner R. E. Smith seconded by Commissioner Eldridge Ellison to advertise for bids Motion Carried.

Motion by Commissioner Eldridge Ellison seconded by Commissioner G. W. Russell, Jr. to accept the written resignation of Ralph McBride as effective September 1, 1980.

Judge brought to the attention of the court concerning a Mini Bus that Vickers-Young Chevrolet had. James Young and Ellis Almokary appeared. The price of the bus was \$3000.00. Council of Governments grant would pay \$2000.00, East Sabine Inc. would pay \$500.00 and James Young through a private donation of \$500.00, Sabine County added the mini bus to the liability Ins. The old mini bus was retained as a stand by.

There were no bids on the Cedar Trees.
