Petitions that had been filed with the clerk as follows were presented: TO THE COMMISSIONERS COURT OF SABINE COUNTY, We the undersigned residents and registered voters of Sabine County, Texas, do hereby petition the Commissioners Court of SabineCounty, Texas, to put the following questions on the November 3, 1980, General Election Ballot:

"Hunters Should Be Allowed To Hunt Deer With Dogs"

"Hunters Should/Be Allowed To Hunt Deer With Dogs" singed by T. V. Todd and 269 others. Appearing on behalf of these petitions were Mrs. Lilliam Cordray and Adrain Click.

Other Petitions which had been filed were presented as follows:
TO THE COMMISSIONERS COURT OF SABINE COUNTY, We, the undersigned residents and registered voters of Sbbine County, Texas do hereby petition the Commissioners Court of Sabine County, Texas not to put the following question on the November 3, 1980, General Election Ballot:

"Hunters Should Be Allowed To Hunt Deer With Dogs"

"Hunters Should/Be Allowed To Hunt Deer With Dogs" signed by Melvin Williams and, 452 others. Appearing on behalf of these petitions were: Billy Joe McGee, Melvin Williams, John Merchant, Steve Fuller, Philip Griffin, Alfred Walden, Hoy Edgar, David Corley, Carl Stewart, Ray Sepulvado. Motion by Commissioner G. W. Russell, Jr. and seconded by Commissioner R. E. Smith to go with the majority and leave as it is now. Voting fn favor was: G. W. Russell, Jr. R. E. Smith and Eldridge Ellison. Abstaining: Jimmy Vickers.

Upon a recommendation by Sheriff Blan Greer, motion was made by Commissioner G. W. Russell, Jr. seconded by Commissioner R. E. Smith to hire Billy Don Sparks as Deputy "Sheriff effective October 1, 1980. All voted in favor of this motion.

A letter concerning a public hearing on Area Wilderness Proposal was brought to the court's attention, which is attached to the minutes of this date and marked "Exhibit A". Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner Jimmy Vickers to pass a resolution that Sabine County Commissioners Court oppose any Wilderness Area in this county. All voted in favor of the motion.

The Tax Appraisal Board notified the court that since Brookeland I.S.D. would not be participating in this District the countys" pro-rata costs would be increased from \$393.87 to \$414.60 per month for 9-1-80 to 12-31-80, and from \$411.66 to \$433.33 per month for 1-1-81 to 12-31-81. Motion by Commissioner R. E. Smith seconded by Commissioner G. W. Russell, Jr. to pay these amounts. Motion carried.

No action was taken concerning Propane for the courthouse. Covington Gas has not submitted their approval by the Railroad Commission and also the city of Hemphill reported they would have the natural gas completed in the downtown area in the near future.

In a budget report for the 1981 budget the County Judge stressed that the court eliminate one hald of the indebtedness in 1981 and the other half in 1982.

Since there were no bids received on the Cedar trees on the Jail site property and upon a recommendation by Judge Smith, O. W. (Red) Mitchell agreed to remove the Cedar trees that were already cut and clean up the brush. Motion by Commissioner R. E. Smith seconded by Commissioner G. W. Russell, Jr. for Mr. Mitchell to do this work. Motion carried.

In the meeting of Sept. 229 1980 the court agreed to get Temple Industries to make our Pre-Application for HUD Block grant at a cost of \$500.00 for single purpose and \$750.00 for Multi-Purpose or Comprehensive. The court has determined that the Deep East Texas Council of Governments will also assist counties in this area for a cost of \$225.00. They would also give credit in our future dues. Motion by

Commissioner R. E. Smity seconded by Commissioner Jimmy Vickers to hire Beep East Texas Council of Governments to make the Pre-Application. Motion carried.

Written resignation of James Allen Payne, County Attorney, was presented to the court. Motion by Commissioner G. W. Russell, Jr. seconded by Commissioner Eldridge Ellison to accept his resignation. All voted in favor. Resignation attached to minutes of this date and marked "Exhibit B".

By request of Judge Smith, Attorney Keith Elolf appeared before the court. He gave a resume of his past work. Since he has not lived in the copunty six months, the Judge of the court will use Provision, Article 2.07 County Attorney Pro Tem for the purpose of appointing Keith Elolf as County Attorney Pro Tem. Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner R. E. Smith and by unanimous consent the court consents to this method of appointment and that he be paid on a contract basis but not to exceed the normal County Attorney salary.

Motion by Commissioner Jimmy Vickers seconded by Commissioner G. W. Russell, Jr. to divide the Federally Owned Land Entitlement money in the amount of \$12,226.00 and the R. & B. Special in the amount of \$4,072.36 percentage wise between the four commissioners precincts. Motion carried.

Accounts were allowed and made payable.

There being no further business the court adjourned.



It has just come to our attention that new proposals for setting aside large areas of Deep East Texas as Wilderness Regions will be the subject of public hearings at the above time and place.

The Sub-Committee will be reviewing four (4) bills with proposed Wilderness designations in Texas.

These bills are: HR4203 by Congressman Bob Eckhardt of Houston to designate 10,700 acres as Wilderness in the Sabine National Forest, Sabine County, known as Indian Mounds. Eckhardt also has HR7599 to designate 10 areas in the National Forest of Texas encompassing 63,000 acres as Wilderness.

The areas in the Sabine National Forest are: Indian Mound and Chamber's Ferry. Chamber's Ferry is in San Augustine County and comprises 4,500 acres. In the Angelina National Forest all three (3) proposed areas are in Angelina County: Turkey Hill - 6,200 acres; Graham Creek - 9,000 acres; Jordan's Creek - 7,800

The only other area in the DETCOG Region is in Trinity County at Alabama Creek in the Davy Crockett National Forest: it comprises 3,400 acres.

Congressman Charles Wilson of Lufkin has 2 bills that will be considered; HR7693 that would declare one of Eckhardt's proposed areas as a Multiple-Use Area and HR7360 for three (3) areas totaling less than 9,000 acres for Wilderness. The only area in DETCOG's Region is at Turkey Hill in Angelina County.

The deadline for reserving time to testify is October 17, 1980.
