Richard A. McDaniel and Easy Martinez, representatives from Southern MicroFilm Corporation met with the court and discussed the filming of old Deed records in the County Clerk's Office. Motion by Commissioner R. E. Smith seconded by Commissioner G. W. Russell, Jr. to film approximately 120 books and have 20 made into new books to purchase this year. The balance to be ordered as the money becomes available. All voted in favor of this motion. The proposal that was discussed is marked "Exhibit A" and attached to minutes of this date.

Joe Liska and Lester Van Pelt III, representatives of York & Associates, which had been collecting Delinquent Taxes for the County Tax Assessor Collector, appeared before the Court. They explained their work and how much they had collected. The Court said the decision would stay as it was made on January 12, 1981, not to renew the contract. The report is attached to minutes of this date and marked "Exhibit B".

By microfilming the large volumes in your office and reprinting them to the same size as your current recordings, it is apparent that you could recover at least 50% of the storage space now being utilized. Of course, the reprinted books are smaller and easier for the public to use, as well as being more durable. Should a page ever by lost or damaged, you need only let us know and we will reprint it from the film at no charge. The important point is that the security film record may be used to reconstruct all or part of your records at any point in the future, should it become necessary to do so. Of course, we would be pleased to film the books in one session and then systematically print them to paper over a period of time, should budget considerations make this a requirement.

According to the enclosed price schedule, Southern Microfilm will provide the following services:

- (1) Books will be prepared for microfilming by checking the sequence and cutting away the binding, or disassembling, as needed for optimum photographic results. It is extremely rare that optimum photographic results cannot be obtained without cutting the binding.
- (2) Microfilming will be accomplished on your premises by professional personnel, using a precision 35mm Kodak microfilmer and Kodak AHU film. A duplex filming mode will be utilized to achieve a two-sided reproduction and optimum packing density for the finished product.
- (3) The film will be processed to archival standards and inspected at our Houston processing laboratory before being used to print reduced size paper copies, front and back, on quality rag content paper. (Sample enclosed). Custom-printed Hazel binders are also furnished as a part of the service.
- (4) Original books will then be placed in special storage cartons and labeled for retirement to a secondary storage area.

On a related subject, the plat maps could be photographed while our mobile camera was set up at the Sabine County Courthouse. These large documents would be recorded on 35mm microfilm for security and then printed to an  $11'' \times 17''$  format for ease of handling and convenient reproduction on a standard office copier. The need to copy segments of these oversize documents and then piece together the prints is thus eliminated. Also, the occasional need for a deputy to accompany a plat map to the blueprinter might be negated by this smaller map size. Please see the enclosed samples which would be representative of the reproductions available from the process. We could perform this service at a charge of 1.27 per map.

We look forward to working with you and your staff to implement these recommendations. If I may provide additional information or be of further service, please let me know.

Re: Proposed Renewal of Tax Contract between Sabine County and Edwin R. York, Jr.

Dear Judge Smith:

The previous tax contract for the collection of delinquent taxes between Sabine County and my firm expired, by law, on December 31, 1980.

Therefore, I enclose herewith for your consideration and for your presentation to the Commissioners' Court for their consideration and action, a proposed new two-year renewal contract, in triplicate originals, together with multiple copies of a separate letter addressed to the Commissioners' Court, with a copy of that letter for each member of the court. In that letter, we furnish a resume of the work performed by us under our previous contract.

The enclosed contract is identical to your previous contract except that the present 15% commission, which will continue for the year 1981, increases to 20% effective January 1, 1982, for the second year of the two-year contract. The new Property Tax Code permits such an increase in 1982, and we feel justified in requesting it due to our increased costs of travel--motels, food and gasolene-and our office overhead--salaries, equipment, supplies, utilities and office rent.

We also enclose a copy of the <u>Instructions Necessary for Making</u> <u>Delinquent Tax Contracts</u> for your guidance in completing the enclosed papers. After all papers have been completed and signed by all Commissioners and by you in all of the proper places, the <u>Waiver</u>, after it has been signed and completed (as to the expiration of his present term of office) as to all three copies, and the <u>Resolution and Order</u>, after all three copies have been completed on both sides by all parties, both need to be recorded by the County Clerk, the volume in which recorded completed in both (the page number is not necessary at this time) and signed and sealed by the County Clerk and a <u>certified copy</u> of both the <u>Waiver</u> and the <u>Resolution and Order</u> regurned to us, along with all the other papers. We will then forward them to Austin for the approval of both the State Property Tax Board and the Attorney General. After Honorable Royce C. Smith

both have approved the contract and other papers, the contract will be returned to your County Clerk for her recordation and she will be requested to return a certified copy of the contract to the State Property Tax Board in Austin. We will then furnish our bond in the amount of \$250.00, as before, for approval of the Commissioners' Court, which will be for the period from January 1, 1981 through December 31, 1982, after which a certified copy of the bond must be sent by your County Clerk to the State Property Tax Board in Austin, whereupon everything will be complete.

If there are any questions concerning the completion of the contract we can answer, please don't hesitateto call us. In the meantime, however, you may want to use your former contract as a guide, a copy of which has been recorded by your County Clerk there in Sabine County.

We have certainly appreciated the opportunity of serving as your Delinquent Tax Attorney during these past years and look forward to a renewal of the enclosed contract, should it be the decision of the Commissioners' Court to the renew it.

Re: Proposed Renewal of Delinquent Tax Contract

Gentlemen:

Our previous tax contract, which began February 12, 1979 and ended, by law, on December 31, 1980, is now subject to renewal. Therefore, we enclose a proposed two-year renewal contract, in triplicate originals, together with a copy of our letter of transmittal to the County Judge, along with this resume of the work performed by us during this two-year period.

During the year 1979, we mailed out some 2395 pieces of correspondence for Sabine County, broken down as follows:

All of the above letters were based on information obtained by us from the tax office, with each item being figured for penalty, interest and cost by us for the month in which each of the various letters were sent out. Commissioners' Court page two

Our records show we filed a total of 15 District Court suits in Sabine County in behalf of the Hemphill Independent School District as Plaintiff and that we filed 7 Interventions in behalf of Sabine County for taxes due the county. Of these, 7 involved only personal property taxes, with which the county was not involved. In the other 8 suits, which involved real property, they were filed only after a title check had been made by us to insure the correct current ownership, including lien holders, if any.

During these two years, we have made frequent trips to Hemphill to work in both the county and the school tax offices, to prepare statement sheets for all delinquent years due the county from 1939 to the present, to check title in the County Clerk's office and at the Minton Abstract Company in Payne & Lord law offices and to post payments, check the status of personal service on the various suits filed and to assist in any problems brought to our attention by the tax officer personnel.

According to our records, our efforts during the period from February 12, 1979 through February 29, 1980 (we have not been paid as yet for the months of March through December 1980, according to our records) have produced some \$20,573.33 in taxes, penalty and interest (not including costs, for which we are not paid.) While we are disappointed in this total, we feel it reflects some of the handicaps we have been confronted with in conjunction with the tax office back-log of mail and unposted payments. We feel that if some of these problems can be worked out, we can spend more time working up additional information for letters urging payment of delinquent taxes and can materially increase collections for Sabine County during these next two years.

We feel that our active program of collections for the Hemphill School during this same period has been of benefit to the County collection program. In the last twelve months alone, our records reflect collections for the Hemphill School in excess of \$46,583.13 and many of these same taxpayers have probably also paid their delinquent county taxes as a result of our insistance that they pay their school taxes.

We would expect to continue our general procedures during the next two years, but would plan to place particular emphasis on putting under suit those items with more than 20 years of delinquent taxes, since, as of January 1, 1982, all years older than the previous 20 years will be wiped out, unless placed under suit in District Court prior to that date.

In addition to collecting taxes for Sabine County during these past two years, our letters have revealed double assessments, changes in ownership, new addresses, and, in some cases, payments which had not been posted to the delinquent tax records, We feel that this information has been of benefit to the tax office and is part of our program in the field of tax collection.
