Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner R. E. Smith to divide R. & B. Special in the amount of \$15,757.12 and R. & B. Tax in the amount of \$2,815.38 as follows:

All voted in favor of the motion.

Motion by Commissioner R. E. Smith, seconded by Commissioner G. W. Russell, Jr. and by unanimous consent the court voted to pay \$150.00 on funeral expense of Dallas Boyett.

Motion by Commissioner Jimmy Vickers, seconded by Commissioner G. W. Russell to approve this plat and file it in Plat Records of Sabine County, Texas. All voted in favor of this motion.

Motion by Commissioner G. W. Russell, Jr. seconded by Commissioner R. E. Smith to pay Costs of Court and Attorney's Fees for case against Sabine County out of Jury Fund. \$200.00 Costs and \$800.00 Attorney fees. All voted in favor of the motion.

Judge Smith informed the court that more work would be done on the Budget the week of October 6th. Motion by Commissioner Eldridge Ellison seconded by Commissioner R. E. Smith to set hearing on Budget Expenditures for October 26th and November 9th. Motion carried.

Accounts were allowed and made payable.

There being no further business, the court adjourned.
