Billy McGee appeared before the court and requested that if the court needed the Right Of Way across his property to go ahead and have an Easement drawn up and he and J. B. McGee would sign it. This was in connection with the decision made at the October 12th meeting. Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner R. E. Smith that the county get an easement made up for this Right Of Way. All voted in favor of this motion.

Mr. Lynn Montes with Axley & Rode Accounting firm appeared before the court and gave the report of the Audit made of the Sabine County Offices. It was found that the Tax Assessor-Collector had liabilities in excess of assets in the amount of \$110,015.11. Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner Eldridge Ellison to turn this matter over to the District Attorney. All voted in favor of the motion.

Motion by Commissioner Jimmy Vickers, seconded by Commissioner R. E. Smith to inform the Attorney General's Office of what has been found through the Audit and ask their assistance in determining what caused it. All voted in favor of the motion.

Although notice was published in the local paper there was no one present to discuss the budget expenditures or make a request.

The Election Returns for the Constitutional Amendments were canvassed. Motion by Commissioner Jimmy Vickers, seconded by Commissioner R. E. Smith to approve the returns. All voted in favor of the motion.

The Appraisal Board Ballot was presented to the court by Judge Smith and the letter stating the County had 1000 votes to cast. Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner Jimmy Vickers and by unanimous consent the court voted in the following way. Joe Tom McMillien 834 votes; Tom Brand 42 votes; Douglas Ray Butler 42 votes; Eugene Procella 41 votes; and Ross Parker 41 votes.

Accounts_were allowed and made payable.

There being no further business, the quirt adjourned.
