Mr. & Mrs. Joe Williams appeared before the court concerning the road that goes by their place. They stated they were trying to get mail service and the postal service would not agree until the road was in better condition. They also said they would buy a convert and the commissioner agreed to put it in for them. Mr. Russell said he was doing what he could but he did not have any gravel.

Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison the resolution acknowledging the acquisition and cost of the high-speed teletype system for out county was passed. All voted in favor of the following Resolution marked "Exhibit A" and attached to minutes of this date.

The county was notified by letter from Reagan Brown, Commissioner of Agriculture the Amdro for fire ants would be ready April 1, 1982. Upon a motion by Commissioner R. E. Smith, seconded by Commissioner G. W. Russell, Jr. and by unanimous consent the court approved the following Memorandum of Agreement marked "Exhibit B" and attached to minutes of this date.

The Jail Construction bids were discussed again and a motion was made by Commissioner G. W. Russell, Jr. and seconded by Commissioner Jimmy Vickers to reject the bids received so far and to asked the Architect, Mr. Grossman to negotiate with the contractor and attempt to secure a price within the amount of the Bond issue and the court requested that the Architect talk to Meigs construction. All voted in favor of this motion.

Mr. Obal Evans appeared before the court and requested the court to appoint him a deputy constable for Brookeland. Mr. A. H. Barlow also appearing before the court also spoke of their need for some law official down at Brookeland. No action was taken at this time as the item was not placed on the Agenda.

Judge Smith made known to the court that under the agreement concerning carssand expense for the sheriff department, Billy Don Sparks wanted the county to pay for his car effective April 1, 1982 and include it on the Fleet Policy of the County. Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner Eldridge Ellison to pay him for his car. The amount set by Mr. Sparks was \$1600.00.

Motion by Commissioner Eldridge Ellison, seconded by Commissioner R. E. Smith to divide the Road & Bridge Special money in the amount of \$8,252.27 in the following manner:

R. & B. #1 -- 22%

R. & B. #3 -- 20%

R. & B. #2 -- 27%

R. & B. #4 -- 31%

Accounts were allowed and made payable.

There being no further business, the court adjourned.
