The Public Responsibility Committee for MHMR must be appointed each year. Mrs. Margo Scherzer who is currently a member of the Public Responsibility Committee has agreed to continue in this capacity. Motion by Commissioner Jimmy Vickers seconded by Commissioner R. E. Smith to appoint Mrs. Margo Scherzer for another year. All voted in favor of the motion.

The Wilson Cooper Road petition was considered next. (The petition is recorded with minutes of September 22nd meeting.) Speaking for the petition to close the road was Q. R. Wilson, Joe Harris and Joe McMillien. Appearing to request the road not be closed were: Arthur and Sherry Elumbaugh. Motion by Commissioner Jimmy Vickers, seconded by Commissioner G. W. Russell, Jr. to leave the road as it is. Voting for the motion was Commissioners Jimmy Vickers, Eldridge Ellison and G. W. Russell, Jr. Commissioner R. E. Smith abstained.

Jack and Sherry Trahan appeared on behalf of the Timberlane Road. Motion by Commissioner R. E. Smith seconded by Commissioner Eldridge Ellison that County accept 6/10 mile of road from Timberlane road to Timberlane Estates Subdivision. (This does not include the roads inside the Subdivision.) Motion carried.

Motion by Commission R. E. Smith, seconded by Commissioner G. W. Russell, Jr. to divide the R & B Special fund in the amount of \$3,996.20 percentage wise between the four Commissioner precincts. Motion carried.


Motion by Commissioner R. E. Smith seconded by Commissioner Eldridge Ellison to divide the Lateral Road money in the amount of \$16,558.03 by 25% to each of the Commissioner precincts. Motion carried.

Motion by Commissioner R. E. Smith seconded by Commissioner Eldridge Ellison to split the Revenue Sharing money in the amount of \$13,173.86 four ways equally to the four commissioner precincts. Motion carried.


Motion by Commissioner R. E. Smith seconded by Commissioner Eldridge Ellison to put the Bureau of Land Management money in the amount of \$11,407.00 in the General County Fund. Motion carried.

Accounts were allowed and made payable.


There being no further business, the court adjourned.
