Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison to pay Temple Associates \$8,100.00 for Architectural service for the Jail. Motion carried.

Motion by Commissioner Eldridge Ellison, seconded by Commissioner R. E. Smith to pay the expense in the amount of \$321.40 of Lawton Crain, Roger McBride and Billy Cannon for attending Teletype Operation School at College Station. Motion carried.

The court expressed its approval for the Tax Statements for County to be mailed in the envelopes with the school.

Bob Garner and others appeared before the court concerning the roads to Shawnee Shores. He said they would help any way they could if they had the equipment down there or even pay the labor for some one to operate the machines. It was suggested that they first contact the Commissioner of Pct. 2 and if came to needing it, Commissioner Jimmy Vickers offered a machine for them to use for a few days.

Mrs. Sudie Ford appeared before the court concerning the #### Scrapping Valley Road. Since this is in Precinct No. 2, she was told the same as above.

Upon a motion by Commissioner Jimmy Vickers, seconded by Commissioner R. E. Smith and by unanimous consent the court ordered the following bill paid for Commissioner Pct. No. 2: B & W. Hardware \$2.24; White's Auto Supply, Pineland, \$77.30; Western Auto, Pineland \$30.08; and Holloway in Brookeland, \$24.00.

Bill Ross with Star Cable TV appeared before the court. He further explained their plan but had to make some changes in the agreement. He will meet back with the court at a later date.






Accounts were allowed and made payable.


There being no further business, the Court adjourned.
