The monthly bills were considered. Commissioner Chester D. Cox, Sr. requested that his bills be held until next court day. Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison that with the exception of R & B #4 bills that all other bills be paid. Motion carried.

Frank Rash, Justice of the Peace, Pct. #1 recommended Gayle Leone as his secretary and requested that she be bonded. Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison to hire her at a salary of \$558.89 and bond her. Motion carried.

Motion by Commissioner R. E. Smith, seconded by Commissioner Billy J. McGee to advertise for bids for a County Depository. Motion carried.

Motion by Commissioner Eldridge Ellison, seconded by Commissioner R. E. Smith that County Officers be compensated on a salary basis for the year 1983. Motion carried.

Bids were called for on the 1978 Dodge (Sheriff's) car. No bids were received.


Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison to pay \$3240.00 to Jail Architect, Temple Associated and \$32,759.00 to Advance Construction, after January 15th. Motion carried.

In compliance with House Bill No. 384 the following public members of the Grievance Committee for Sabine County were drawn as required by law: Terry Clifton, P. O. Box 834, Hemphill; Tony W. Greer, Holly Park, Milam, Texas; and Bill Jones, P. O. Box 505 Pineland, Texas. Motion by Commissioner Eldridge Ellison, seconded by Commissioner R. E. Smith to approve this act. Motion carried.

Motion by Commissioner R. E. Smith, seconded by Commissioner Billy J. McGee to amend the 1983 Budget and give permission to Commissioner of Pct. #2 to use Revenue Sharing money to buy parts and other expenses to get machinery to running again. Motion carried.

The salary of Constables was brought up. The matter was tabled to be put on the Agenda for next court day, January 21, 1983.

There being no further business, the Court adjourned.
