Mr. Mark Hughes, representing the Office of Bill Clemons, State Representative, met with the court.

Monthly reports of the various offices were reviewed by the court.

Commissioner Billy Joe McGee brought up the condition of the garbage situation of Beechwood Dump. He said he could only afford a man there part time and if the man was not there garbage was not always placed in the right place. Motion was made by Commissioner Billy Joe McGee to keep the Garbage Dump open three days a week, being Sunday, Monday and Thursday and that charges would be filed on persons placing garbage outside the dump. Commissioner Chester D. Cox, Sr, seconded the motion and Motion carried.

A request from the Johnny Wells SubDivision to erect a sign in the Subdivision (Children at Play) was made. Motion by Commissioner Chester D. Cox, Sr., seconded by Commissioner Billy Joe McGee that the request be granted and that the Subdivision bear the expense. Motion carried.
