Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to divide the Road & Bridge Special which is for Auto Registration for the period of 6-6-83 through 6-17-83 in the amount of \$10,757.34 percentage wise between the four commissioner precincts. Motion carried.

Jeff Diebold met with the court. He had been contacted concerning getting a place for gravel for county roads. He thought something could be worked out with Kirby Company for a gravel pit as long as it was not over 2 acres and did not molest; the Young Plantation. He agreed to meet the commissioners at a place they had found to get gravel.

The bill from the Audit firm of Alexander and Rogers was discussed. The commissioners asked Judge Smith to contact the firm for the bill in the amount of \$4500.00 to be itemized before payment.

Motion by Commissioner Billy Joe McGee, seconded by Commissioner R. E. Smith to approve the Lateral Road Report to be sent to State Treasurer of expenditures of Lateral money. The court voted to approve the following report marked "Exhibit A" and attached to minutes of this date.

The auditing firm had requested that the court clearily the type of reports, what they should contain and the date to be turned Billy Joe McGee in to the court. Motion by Commisssioner, /seconded by Commissioner Chester D. Cox, Sr. that the reports contain the amount collected and itemized as to what it was for and the amount of undistributed funds in each account. The report is due the First Meeting of each month.
