The meeting was called to order by the County Judge. The bills were examined and made ready for payment. Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to approve the payment of bills. Motion carried.

Marie White, Tax Assessor-Collector met with the court to ask for extra help in her office, since one had been given an leave of absence due to the investigation in her office. She recommended Cindy Hampshire and would hire her through the Government Training Program if she qualifies. The court gave her permission to hire her at the expense of the county if she does not qualify on the government program.

A bid was submitted by Geo. P. Bane, Inc on a used Fiat-Allis M 100 B with Scarifier motor grader/ in the amount of \$25,000.00. Since Commissioner Eldridge Ellison was sick and not at the meeting, Motion by Commissioner R. E. Smith, seconded by Commissioner Billy to table accepting the bid until Commissioner Ellison could be here. Motion carried.

Motion by Commissioner Billy Joe McGee, seconded by Commissioner R. E. Smith to advertise for bids for 4 inches of Concrete on the Jail Parking Lot or 2 inches of Asphalt. Bids are to be opened on August 13th at 9:00 A. M. The court reserves the right to reject any or all bids. Motion carried.

County Judge announced to the court that the Texas Highway Department would hold a hearing on August 21st at 10:00 A. M. concerning the paving of the road in Commissioner Pct. No. 4 and a hearing at 1:00 P. M. the same date on the road in Commissioner Pct. No. 2.

Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to divide the Revenue Sharing money in the amount of \$8,754.00 by putting it all in the General County Fund to be used to pay bills. Motion carried.
