The meeting was called to order by the County Judge, The bills were examined and made ready for payment. Motion by Commissioner Billy Joe McGee, seconded by Commissioner Eldridge Ellison to pay bills that were approved. Motion carried.

The bid on the Motor grader for Precinct No. 3 that had been tabled in a prior meeting due to the illness of Commissioner Eldridge Ellison was examined. Motion by Commissioner Eldridge Ellison, seconded by Commissioner R. E. Smith to accept the bid from George P. Bane, Inc. for One used Fiatallis M100B Motor grader Serial No. 6906 and to issue a Time Warrant for \$25,000.00 To First State Bank, Hemphill, Texas. See Resolution and Bid marked "Exhibit A" and attached to minutes of this date.

Motion by Commissioner Billy Joe McGee, seconded by Commissioner R. E. Smith to Amend the Revenue Sharing Budget for R. & B. #2 by adding \$244.61 and R. & B. #3 by adding \$734.94. Motion carried.

Motion by Commissioner Billy Joe McGee, seconded by Commissioner Chester D. Cox, Sr. that before a person is hired by the County, they must pass a physical examination. It should be a general physical examination including Exrays. The examination should determine whether the person is able to do manual physical labor. Motion carried.

Bids were called for on surfacing the parking lot for the New Jail. There were three for Asphalt surfacing and two for Concrete. Motion by Commissioner Chester D. Cox, Sr., seconded by Commissioner Billy Joe McGee to take these bids under consideration and that it be an Agenda item for the next meeting. Motion carried. Marked "Exhibit B" and attached to minutes of this date.

There being no further business, the court adjourned.

RESOLUTION
