Mrs. Blanche Toole who is now Chairman of the 1986 Sesqui-Centennial would like to relinquish this position to Wally Kittman. Motion by Commissioner R. E. Smith, seconded by Commissioner Chester D. Cox, Sr. to appoint Wally Kittman to this position. Motion carried.

County Clerk, Minnie Gooch explained to the court the new laws concerning Voting Booths and access to the Polling Places for the Handicapped. Action will be taken on these matters when more information is received.

Diane Husband, Tax Assessor-Collector informed the court of the resignation of Christy Nichols. She also recommended Janie Winslow to this position. Motion by Commissioner Chester D. Cox, Sr. seconded by Commissioner Billy Joe McGee to accept the resignation of Christy Nichols and to hire Janie Winslow to this position,

effective June 21st. Motion carried.

A group concerning the Whitehead Road appeared before the Court. Motion by Commissioner Billy Joe McGee, seconded by Commissioner R. E. Smith to accept as a county road the spur off Hubert Whitehead Road pass the Whitehead Cemetery as it had bken partially maintained by County for years. Motion carried.

Next to be considered was the road into the Buford Bennett place. Motion by Commissioner R. E. Smith, skconded by Commissioner Billy Joe McGee that this road has been maintained by the county ## for at least 12 or 15 years and it is a county road. Motion carried.

Motion by Commissioner Chester D. Cox, Sr., seconded by Commissioner Billy Joe McGee to give Treasurer authority to disburse \$21,168.69 to Everett & Griffith & Associates and \$1,278.24 to Deep Eⁿst Texas Council of Governments on the construction of FM road which is under contract. Motion carried.

Motion by Commissioner Chester D. Cox, Sr., seconded by Commissioner Billy Joe McGee that the old San Antonio Road from Ben Payne curve on State Hwy. #21 via the Canton-Gasby Cemetery annot on to its intersection with Hwy. #21 again, being the Geneva Community Development Block Grant Road be classified as a first class County Road, 50 ft. wide. This being a safety measure to protect the traveling public and that a blanket easement bearing 32 names be filed in the County Clerk's office. Motion carried. Exhibit A"



Beginning at a point where the center line of said road intersects the west right of way line of State Highway Number 21; said point being in a ninety degree curve south of Geneva.


