The meeting was called to order by County Judge, Royce Smith. The bills were examined and made ready for payment. Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to pay current monthly bills. Motion carried.

Maurice Walker called County Judge and stated that they had come to an agreement on the road leading to his home also known as the Craig road and he would not need to meet with the court.

The roof on the courthouse was discussed. One man was already contacted and had gone up and looked at it. No definite plans have been made to have it fixed.

John Toner, County Agent, presented certificates to County Treasurer, Ollie Faye Sparks and County Judge, Royce C. Smith for having completed the Seminars held at College Station A. & M. University. Mr. Toner stated he was proud for the Elected Officials to further educate themselves to the duties of their respective offices by attending these schools taught by V. G. Young Institute.

Diane Husband, County Tax Assessor-Collector presented her financial report to the court for the first six months and also a monthly report.

Mrs. Marie Neal met with the court concerning timber that has been cut off her land without permission by Commissioner Chester D. Cox, Sr. She stated that she talked to him on telephone and he asked if she had a deed, which she did. She stated that she waited for a few days and heard nothing more, so she wrote him a letter and he did not answer it. She informed the court she wanted something done about this immediately. The court went out to the land immediately following the session.

Motion ;by Commissioner Eldridge Ellison, seconded by Commissioner Billy Joe McGee to accept the bid by Everett F. Murray on the 1970 Chevrolet Truck, Pct. No. 3 for \$450.00. Motion carried.

Commissioner Billy Joe McGee made motion not to accept the bids for 1975 Dodge Truck for Pct. No. 2. Seconded ;by Commissioner R. E. Smith and motion carried.

Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison to table the bids for Pct. No. 4 truck and the Sheriff's car until the next meeting being August 12, 1985. Motion carried.

Motion by Commissioner Eldridge Ellison, seconded by Commissioner Billy Joe McGee, that anyone caught removing Bridge Signs or any signs on County roads would be subject to a fine of not less than \$500.00. This is theft or destruction of a sign. Motion carried.

There being no further business, the court adjourned.
