The meeting was called to order by County Judge, Royce C. Smith.

Commissioner Billy Joe McGee made motion for payment of bills.

Commissioner Eldridge Ellison seconded. Motion carried.

The State called the Judge last week, and said they have 5 available 100 V - 10 scan (channel) CB Radios at \$350.00 each if the county wants to buy them for the Sheriff's Department. Commissioner Eldridge Ellison made motion to approve this buy, and make it an amendment of the budget. Commissioner Rob Smith seconded. Motion carried.

The County has been operating of a continuation of the old budget, total value received from Appraisal District was \$223,700, total amount of budget is\$1,684,406-money County thinks it will receive is \$1,610,558. Commissioner Rob Smith made motion to adopt the budget. Commissioner Billy Joe McGee seconded. Motion carried.

Allocation of Ad Valoren Tax Money to be divided in budget as follows: ((percentage wise):

General County: was 37% - lowered to 35%

Jury Fund stays at 2%

Road & Bridge was 15% - raised to 20%

Officer Salary was 25% - lowered to 21%

Jail Bond was 21% - raised to 22%

Commissioner Rob Smith made motion to accept this, Commissioner Billy Joe McGee seconded. Motion carried.

Rhonda Williams, Deputy from the Tax Collector-Assessor appeared in court in case there were any questions in reguards to the Tax Office. There were no questions.

Election returns were canvassed and motion was made by Commissioner Eldridge Ellison to approve. Commissioner Billy Joe McGee seconded. Motion carried.

Commissioners voted the ballet for the Appraisal District Board members.

Commissioner Billy Joe McGee made a motion and Commissioner Chester Cox, Sr. seconded, that all Justice of the Peace of Sabine County will receive \$25.00 per inquest. Motion carried.

Commissioner Rob Smith made motion to change hourly employee,
Dorothy Nobles to the Starting Monthly salary. Commissioner Eldridge
Ellison seconded. Motion carried.

Commissioner Rober Smith made motion and Commissioner Eldridge Ellison seconded, for the courthouse to be closed at 12 noon on Tuesday, Dec. 24, for the rest of the week, for Christmas holidays. New Years was tabled.

Motion was made by Commissioner Rob Smith, Seconded by Commissioner Billy Joe McGee, to accept the Fire Protection Contract, City of Hemphill & Sabine County. Motion carried. See Exhibit A.
