On this the 25th day of November, 1985, the Honorable Commissioners' Court met in Regular Session with the following members present, to-wit:

Chester D. Cox, Sr.	Commissioner, Precinct No. 4
Minnie Gooch	Clerk of the Court

The meeting was called to order by County Judge, Royce C. Smith.

Motion by Commissioner Billy Joe McGee, seconded by Commissioner Eldridge Ellison to pay County Bills as listed. Motion carried. List marked "Exhibit A" and attached to minutes to this date.

Judge Smith read a letter received from MND Drilling Corp. P. O. Drawer 109, Magnolia, Texas 77355 asking information in moving over sized load over county roads. The court stated the bridges are restricted to 12 tons and the roads are to be repaired that are torn up.

Motion by Commissioner Billy Joe McGee, seconded by Commissioner R. E. Smith to approve Six Mile Bridge Federal Grant Project as previously agreed upon in the August 26, 1985 meeting of the commissioners Court and to notify Temple Industries and Forest Service. Motion carried.

Court informed the Commissioners that a 1975 Van and 1976 van and 1979 4 door Chrysler, sheriff's car and Emergency Generator needed to be sold. Commissioner Billy Joe McGee said Pct. #2 had a 1975 Dodge Dump Truck to sell. Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison to advertise for bids to sell these items. Motion carried.

Kent Walker from Woodland Estates met with the court stating the residence of Woodland Estates Subdivision had money

to work on the streets in this subdivision and part of these streets had been accepted by the County so they needed permission from the county to do this work. Motion by Commissioner Billy Joe McGee, seconded by Commissioner R. E. Smith to give this permission to work these streets with no responsibility to the county. Motion carried.

Will Lathrop met with the court concerning the use of County Right of Way in Pct. #2 for South Sabine Water Supply. Motion by Commissioner Billy Joe McGee, seconded by Eldridge Ellison that permission be given and should state in the Contract that as these roads are damaged the Water District has to put back in existing condition as they are now. Motion carried.

Tax Assessor-Collector, Diane Husband met with the court and gave a report on the progress of the Tax Statedments. Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to extend the Discount time as follows: December 3%, January 2%, and February 1%, due in March and Delinquent in April. Motion carried.

Motion by Commissioner Billy Joe McGee, seconded by Commissioner R. E. Smith to pay the insurance on Sammy Girolamo family and if he fails to re-emburse the county then the insurance stops. Motion carried.

For New Years Holiday, motion by Commissioner Eldridge Ellison, seconded by Commissioner R. E. Smith to set December 31 and January 1 for New Years Holidays. Motion carried.

Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to acknowledge the returns of the Election of the Appraisal Board Members as reporter by County Clerk, Motion carried. Marked "Exhibit B" and attached to minutes of this date.

Letter received from State Department of Highways reporting the number of miles for Sabine County was 360 was read by the Court. Motion by Commissioner Billy Joe McGee, seconded by Commissioner Eldridge Ellison that this is the correct mileage for Sabine County Roads. Motion carried.

W. L. Turner, Appraisal Board Member spoke to the court and gave reports which he had obtained about the meeting of the Board.



Thomas Hamilton appeared before the court and stated the Contractor that was building the Community Block Grant Road would be possibly delayed until March 1, 1986.

There being no further business, the court adjourned.


