The meeting was called to order by County Judge, Royce C. Smith. The bills were examined and made ready for payment. Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to pay monthly bills. Motion carried.

Ronnie Stewart met with the court about the road into his house Forestry road #153. He was told to contact the Forest Service since it was their road.

Forest Service Check in the amount of \$432,538.32 has been received. Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to divide in the usual manner as figured by the County Treasurer. Motion carried. See "Exhibit A" attached to minutes of this date.

~~Walter Diggles~~ Deep East Texas Council of Government met with the court concerning a change order in construction of road in Commissioner Pct. No. 4. Motion by Commissioner Chester D. Cox, Sr. and seconded by Commissioner Eldridge Ellison to approve this change to delete material and installation required for four feet of aluminum pipe culvert in the amount of \$400.00 decrease. Motion carried. See Exhibit B attached to minutes of this date.

Construction on the above road has been delayed due to the rainy weather. Thomas Hamilton who has been overseer of the road project will report to the contractor if weather permits before March 1, 1985 so the construction will not be delayed as much in case the weather permits work on the road before this date. See "exhibit C" attached to minutes of this date.

Ottis Moore is presently the Minority Representative from Sabine County on the Board of Directors for the Deep East Texas Council of Governments and Economic Development District. Motion by Commissioner Chester D. Cox, Sr. seconded by R. E. Smith to reappoint him to serve for the year 1986. Motion carried. See "Exhibit D" attached to minutes of this date.

Bids were called for which had been advertised for the sale of vehicles. One bid was received from Hemphill Motor Company. Marked "Exhibit E" and attached to minutes of this date. Motion by Commissioner Chester D. Cox, Sr., seconded by Commissioner Billy Joe McGee to reject these bids. Motion carried.

Motion by Commissioner Billy Joe McGee seconded by Commissioner R. E. Smith to set a price on the Sheriff Car for sale at \$500.00. Motion carried.

Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison to advertise for bids to buy a new Sheriff's Car four door Policy package Vehicle with a trade in. Motion carried.

Motion by Commissioner Billy Joe Smith, seconded by Commissioner R. E. Smith to pay off time warrant in the amount of \$25,000.00 on FG Fiatallis Motor Grader. Motion carried.

Motion by Commissioner Eldridge Ellison, seconded by Commissioner R. E. Smith to pay off time warrant on Elevator out of Revenue Sharing money. Motion carried.

Edna Robinson, Secretary of Justice of the Peace, Pct. No. 1 met with the court and asked that her salary be raised up according to what others in the courthouse were making. Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to raise her salary from \$616.00 to \$728.00 effective January 1, 1986. Motion carried.

1. NECESSITY FOR CHANGE/IMPACT ON LOW/MODERATE INCOME AND OVERALL PROJECT BENEFICIARIES:

The beveled ends of the culvert pipes were delivered with an error in their fabrication. To have these ends again fabricated and delivered would cause considerable delay in the project. The ends can be field cut to the correct configuration but will shorten the overall length of each of the four culvert barrels by one foot. This change order employs this latter option and deducts the cost of the four feet of culvert installation and materials from the contract amount. The impact of this change is to slightly reduce the cost of the project and slightly increase the slope of the embankment at the bridge.

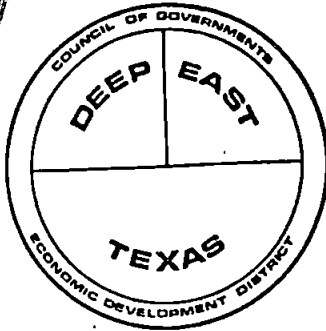

Mr. Jerry Clark of Everett Griffith, Jr., and Associates began the meeting by addressing the Sabine County CDBG Project construction delays. Mr. Clark informed the contractor, Mr. L. L. Matthews, that requests to postpone construction start should be made to the Project Engineer.

Mr. Matthews explained that heavy rains in the project area were the primary basis for the delay in construction start and also the reason for his request to postpone construction until early spring of 1986 (March).

Walter Diggles explained TDCA position on the construction delay. He stated that there was no problem with the rain delays, however, Mr. Diggles pointed out that it would be to the County's best interest to start construction as soon as possible due to the relationship between the status of existing projects under the TCDP Program and eligibility for competing under the current funding year.

After a lengthy discussion of the pros and cons of construction start time, Commissioner R. E. Smith and Commissioner Chester Cox suggested that work be postponed and that Mr. Thomas Hamilton would report to the contractor if weather conditions should become favorable before March. Construction would begin accordingly.

Mr. Matthews and Mr. Clark discussed the problem with the aluminum culverts. They were going to be 44' long instead of 45' long.

Walter Diggles explained that a change order would be required with approval by the Texas Department of Community Affairs.

It was noted that these recommendations would be made officially to the Sabine County Commissioners Court on December 23, 1985, for their action.
