The meeting was called to order by County Judge, Royce C. Smith. The monthly bills were examined and made ready for payment. Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison to pay monthly bills. Motion carried. *Exhibit "A"*

Diane Husband, County Tax Assessor Collector met with the court and gave a report of the amount of taxes collected and also a report on the Voters Registration which was being worked on and cards would be mailed out during the month of January.

Mr. A. L. Walker from Brookeland met with the court concerning the Sanitary Land fill in Brookeland and also the roads going to his place. Mr McGee stated that he graded the road as often as he could that some of the roads were in worse condition and he tried to see to them first.

The Sabine County Commissioners Court selected the Salary Grievance Committee according to Art. 3912k. Members selected from the Grand Jury was W. W. King, Rt. 1, Box 26 A, Bronson, Texas; William L. Williams, Pineland, Texas; Joe G. McGee, Rt. 1, Box 628, Hemphill, Texas; Jimmy Boyett, Rt. 2, Box 136, Bronson, Texas along with the County Judge, Sheriff, Tax Assessor-Collector, Treasurer, and County and District Clerk. Motion by Commissioner Billy Joe McGee, seconded by Commissioner R. E. Smith to approve this committee. Motion carried.

Judge Smith informed the court that a letter had been received from County Clerk that 2 vacancies were on the Sabine County Appraisal Board and nominations were in order to fill these vacancies. Nominations were Will Lathrop and Thomas Hamilton. Motion by Commissioner R. E. Smith seconded by Commissioner Eldridge Ellison,

to present these names to the appraisal board. Motion carried.

Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to compensate the County Officials on a Salary Basis for the year 1986.

The Court went into Executive Session concerning the County Line or Boggie Road Farm Road # 3448.

Executive Session closed and the following motions were made.

Motion by Commissioner Billy Joe McGee, seconded by Commissioner Eldridge Ellison to offer Dr. Felix N. Rutledge \$882.00 for his Right of Way and give him 60 days to get the timber off. Motion carried.

The offer for the Hankla property was \$1302.00.

Motion by Commissioner Chester D. Cox, Sr., seconded by Commissioner Eldridge Ellison that County Attorney Pro Tem Elizabeth Brice file writ immediately on those that are not in agreement with the settlement offer. Motion carried.

There being no further business, the court adjourned.
