Motion by Commissioner R. E. Smith, seconded by Commissioner Billy Joe McGee to pass Resolution giving authority for Sheriff to enter into new contract with the Corp of Engineers for patrolling Lake area. Motion carried.

Justices of the Peace Frank Rash, Mike Carmichael and George Booth met with the court concerning a raise in their salary. Since the budget was already in effect the raise was not considered at this time.

Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison to put Edna Robinson's salary back where it was until next budget. Motion carried.

Bids were opened at 9:00 A. M. as advertised. Bid from Hemphill Motor to buy 1975 Van was \$351.00, 1976 Van \$451.00. Bid to sell Sheriff car, Hemphill Motor was \$12,200.00. The bid from McCoury Chevrolet to sell Sheriff car was \$12,593.14. Motion by Commissioner Billy Joe McGee seconded by Commissioner Eldridge Ellison to carry bids over to next Court date. Motion carried.
