The meeting was called to order by County Judge, Royce C. Smith. The monthly bills were examined and made ready for payment.

Motion by Commissioner Billy Joe McGee, second by Commissioner R.E. Smith, to pay monthly bills. Motion carried. List of bills marked "Exhibit A" and attached to minutes of this date.

Bill Akers appeared before the Court concerning numbering of County Roads. The matter was discussed but no written action was taken. However, Commissioner Chester Cox will start as soon as practical starting a review of a numbering system.

Lee Martin with G.M. Water Cooperation appeared before the Court concerning Right-of-way for extension of G.M. Waters to Thomas Johnson, F.M. 1368. Also extension of water lines south of Pineland on Hi-way 96. Motion by Commissioner Billy Joe McGee, second by Commissioner R.E. Smith to grant County Easement concerning County roads that are involved for the extension as listed by G.M. Water Cooperation. Motion carried.

Lamar Thomas and Charles Hall appeared before the Court concerning a road problem. The situation was discussed but no Court motion was made. Both parties agreed to use cattle-gaurds to resolve the question.



Motion by Commissioner Billy Joe McGee, second by Commissioner R.E. Smith to pay Deep East Texas Council of Governments bill of \$2,205.04. Check is for Administrative Services on the CDBG Project on the Old San Antonio Road in Precinct No. 4 Road Project, No. 00025317084. Motion carried.
