

The Honorable Sabine County Commissioners' Court met in a Regular session Monday, August 11th at 8:30 o'clock A. M. with following members present:

The meeting was called to order by Judge Royce Smith.

The County bills were reviewed and made ready for payment. Commissioner Billy Joe McGee made motion, seconded by Commissioner R. E. Smith to approve payment. Motion carried.

Weldon Gaston with the State Highway Department met with the Court concerning the replacement of a bridge on Hwy. 1592 in Prct. # 3. They need two temporary easements to re-route traffic during the construction of this bridge. The property belongs to the P. M. Coussons estate and J. H. Minton estates, so they will have to have easements from them. After construction is completed, the property will go back to property owners.

Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith to accept the resignation of Sammy Girolamo, Constable, Prct. # 5, to be effective immediately. Motion carried. Also, Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith to appoint Paul Clark ^{to} fill his unexpired term. Motion carried. This appointment is to be effective as soon as Mr. Clark is sworn in. See attached letter.


Commissioner R. E. Smith made motion to adopt the budget for 1986-1987; Commissioner McGee seconded the motion. Motion carried with 4 for, 0 against.

The Tax rate was set at 26¢, which was the same as last year, with Commissioner Billy McGee making the motion and Commissioner Eldridge Ellison seconding. Motion carried.

Tax Assessor-Collector, Diane Husband asked the Court to certify the 1986 Tax Roll for Sabine County and Sabine County Hospital District. Commissioner Chester Cox made the motion, seconded by Commissioner Eldridge Ellison to certify Roll. Motion carried. See attached exhibit.
