


On Monday, September 22, 1986, the Honorable Commissioners' Court met in an Emergency meeting at 2:00 P. M., in the County Judge's office.


The meeting was called to order by Judge Royce C. Smith.




Motion was made by Commissioner Eldridge Ellison, seconded by Commissioner R. E. Smith that meeting adjourn. Motion carried.




In that letter I requested that the court reconsider their action and increase the salary of county clerk, county treasurer and county tax assessor-collector to a level commensurate with that voted by the court on August 5, 1986. 

Please be assured we hold the utmost respect for the parties involved we do however feel that there has been a grave error in judgement. Please allow me to quote from the following Article 3912G, " Sec.1. The Commissioners Court in each county of this State is hereby authorized, when in their judgment the financial condition of the county and the needs of the officer justify the increase, to enter an order increasing the compensation of the precinct, county and district officers, or either of them, in an additional amount not to exceed twenty-five (25%) percent of the sum allowed under the law for the fiscal year of 1948, whether paid on fee or salary basis; provided, however, the members of the Commissioners Court may not raise the salaries of any of such Commissioners Court under the terms of this Act without raising the salary of the remaining county officials in like proportion." In my opinion an increase in the amount of 31% was indeed excessive, as an elected official I would however ask that the laws as described above be adhered to. I would also like to mention that in Sec. 4 there was a provision made that provides for no salary increases of elected officials be made without first notifying a newspaper at least 3 consecutive weeks before the desired increases are put into effect. I feel that this provides a serious background for misinformation to the general public, they are in fact responsible for the salaries of all county officials and I feel it is our responsibility as elected officials to provide them the courtesy of being notified of any increases in salaries. I appreciate your honesty and would appreciate hearing from you at your earliest possible convenience.
