Meeting was called to order by Judge Smith. Opening prayer was led by Brother Clarence Howell.

Minutes of the last meeting were read by Deputy Clerk, Janice McDaniel.

Motion was made by Commissioner R. E. Smith, seconded by Commissioner Eldridge

Ellison to approve reading of the minutes. Motion carried.

Judge Smith swore in new County Attorney Herbert Fortson.

Monthly bills were inspected and made ready for payment. Motion was made by Commissioner R. E. Smith, seconded by Commissioner Billy McGee to approve payment of bills. Motion carried.

Motion was made by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison to divide Lateral Road check of \$ 15,785.63 equally between the four precincts. All voted in favor.

The Treasurer's report of fines and fees collected during the month of October was presented to the Court. Motion was made by Commissioner Billy McGee, seconded by Commissioner R. E. Smith to approve reports. All voted for.

Judge Smith recognized Louise McCary who represented a deligation of residents from the Delta Heights Road in Precinct 2 in Pineland, concerning the fixing of the road. Motion was made by Commissioner Billy McGee, seconded by Commissioner Chester Cox to accept this road as a County miantained road. Motion carried.

A petition was made by Mrs. O. E. McCluskey of Precinct 2 in Brookeland to close 117 feet of road in front of her home. Commissioner McGee made the motion to begin the process to legally close this road. Commissioner R. E. Smith seconded the motion and all voted for.

The only bid received for the repair on roof of courthouse was from Jatex Construction, Inc. of Jasper. This bid was for completing the reroofing of all sloped walls, and installing new gutter and downspouts as specified for the sum of \$13,271.50, plus the additional cost of replacing decayed facia estimated at \$1,400.00. Motion was made by Commissioner McGee, seconded by Commissioner R. E. Smith to accept this bid. All voted for "See attached exhibit."

After canvessing the election, motion was made by Commissioner Chester Cox, seconded by Commissioner Billy McGee to approve the canvessing. Motion carried.

Motion was made by Commissioner Cox, seconded by Commissioner McGee that meeting adjourn. All approved.
