

On Monday, November 24, 1986, the Honorable Commissioner's Court met in a regular meeting after being called to order by Judge Royce C. Smith. Opening prayer was led by Brother Clarence Howell. Members attending were:

Minutes of the last meeting were read by Nadine Gary, County Clerk. Commissioner Eldridge Ellison made motion, seconded by Commissioner R. E. Smith to approve reading of minutes. Motion carried.

Christmas and New Years holidays were set by the Court. The Courthouse will be closed December 24, 25, and 26, and January 1 and 2.

Monthly bills were made ready for payment. Commissioner Billy McGee made motion, seconded by Commissioner Eldridge Ellison to approve payment of bills. All voted for.

Judge Royce Smith informed the Court that the Public Address System that was purchased for the third floor Courtroom has been installed. Mike stands are on order, and will be installed in the near future.

County Attorney Herbert Fortson asked for a temporary County Courtroom to use for disposing of County Cases. He stated that we are so far behind because we have to schedule County Court when the District Court is not in session. Also effective January, 1987 the County Attorney's office will be located on the first floor of the Courthouse in what is presently the District Clerk's office. The District Clerk's office will be located on the third floor next to the Courtroom.

Commissioner Billy McGee offered storage space for ^{obsolete} County equipment and supplies at his County barn at Yellowpine. This will make room for more office space in the Courthouse. After a discussion on this, Commissioner McGee made motion seconded by Commissioner Eldridge Ellison. All were in favor.

Judge Smith informed the Court that the County needed to advertise for bids for a County Depository, County gas and oil, and for a County Audit. Motion was made by Commissioner R. E. Smith, seconded by Commissioner Billy J. McGee to advertise for bids on December 22, for oil, gas, and an audit, and on January 12, 1987 for the County Bank Depository. Motion carried.

Commissioner R. E. Smith made motion, seconded by Commissioner Eldridge Ellison the meeting adjourn. Motion carried.

Gentlemen:

We are pleased to submit our bid to reroof all sloped walls, and install new gutters and downspouts to the following specifications:

New composition shingles to be Prestique II shingle by Elk with a 25 year warranty and a class "A" fire rating. New shingles to be nailed over existing shingles. Remove any existing shingle tabs that may effect the new shingles from laying flat. New shingles to be nailed in place with 1-1/2" galvanized #11 roofing nails. No staples. Four nails per shingle.

Existing lead flashing and vent covers may be reused if they are in good condition when removed. Any decayed or missing facia or trim to be replace. We estimate about \$1,400.00 of decayed facia that will need to be replaced. This will be charged extra.


All existing gutters and downspouts to be removed and hauled away. New gutters to be one piece construction, 26 gauge galvanized 5" box type with eave trim, shop fabricated. New downspouts to be 3" x 4" corrugated standard with 3 downspouts straps per downspout. All gutter and downspouts joints to be pop rivets and solder. New gutter supports to be no less than 4' on center. Four new downspouts in addition to existing.

All new material to be primed.

Jatex Construction Co., Inc. hereby proposes to complete the reroofing of all sloped walls, and install new gutter and downspouts as specified for the sum of **THIRTEEN THOUSAND, TWO HUNDRED, SEVENTY-ONE AND 50/100 DOLLARS (\$13,271.50)** plus the additional cost of replacing decayed facia estimated at **ONE THOUSAND, FOUR HUNDRED AND NO/100 DOLLARS (\$1,400.00)**.
