

On Monday, January 12, 1987 the Honorable Commissioners Court met in a regular session with the following members present:

Meeting was called to order by Judge Royce Smith. Opening prayer was led by Brother Clarence Howell.

Minutes of the last meeting were read by Nadine Gary, County Clerk. Motion was made by Commissioner Eldridge Ellison, seconded by Commissioner R. E. Smith, to approve reading of minutes. Motion carried.

Monthly bills were made ready for payment. Commissioner Smith made motion to approve payment of bills; Commissioner McGee seconded motion. All voted in favor. Motion carried.

The Treasurer's report, Tax Assessor-Collector report, and the County and District Clerk's office reports were reviewed. Commissioner R. E. Smith made motion, seconded by Commissioner Eldridge Ellison to approve reports. Motion carried.

Commissioner Billy Joe McGee made motion, seconded by Commissioner R. E. Smith to approve the petition presented by Mr. & Mrs. O. E. McCluskey to close 117 feet of the road that is known as the old Brookeland-Yellowpine Road located in Precinct # 2. Motion carried. After the names on petition have been verified by the County Clerk, and the petition has been posted for 20 days, the Commissioners Court will vote to decide if the road should be closed. "See exhibit attached."

Bids were opened for County Depository for 1987. First State Bank of Hemphill was the only one received. First State Bank vice president, Robert Russell, delivered the bid to the court, and remained to render comments and answer questions. He submitted one bid with an alternative that will allow the county to earn more interest on some of its funds. Commissioner Billy McGee made a motion to present the bid to the county's C.P.A. and take action upon his advice. Commissioner Chester Cox seconded the motion and all voted in favor.

Vince Sherlock asked the court why the Treasurer does not give a report at each meeting. Judge Smith explained that a copy of her report is at each meeting, and a listing of bills and invoices are available for inspection.

The Court was informed that the U. S. Forest Service has several thousands of acres located in Sabine County. 25% of the revenue the Forest Service receives from lands in our county is returned to us each year. Fifty percent of this goes to the School districts in the county. Commissioner R. E. Smith made a

motion, seconded by Commissioner Eldridge Ellison, to divide the Forest Service check as follows: Road and Bridge Funds: Prct. # 1, \$23,525.16; Prct. # 2, \$28,871.79; Prct. # 3, \$21,386.51, Prct. # 4, \$33,149.10. County schools would receive the follows: Hemphill I.S.D. - \$150,252.04, West Sabine I.S.D. \$43,535.93, Brookeland I.S.D., \$ 18,203.17, Shelbyville I.S.D. - \$5,021.04. The funds also included a 5 percent commission of \$10,850.61 and \$99,229.00 for Commissioner's salaries. All voted for. "See attached exhibit."


Madeline Hauser met with the court concerning condition of Farm Road 2928 in Prct. # 2. This road goes into Foxes Lodge, and she said they are in terrible condition. Commissioner McGee answered he had discussed the condition of this road with Pat Fox, owner of Foxes' Lodge.

Geneva Hignite and other residents of Sam Rayburn Estates reported to the Court on the condition of the County Line Road in Prct. # 2. She said of the 112 property owners in this subdivision, there are 40 homes, with 17 families living there all time. There are times when it is impossible to get their cars in and out. Mrs. Hignite also stated they now have a petition in Austin, and they are going to Austin to try to get a solution. Commissioner McGee answered he feels the only solution will be to get the road accepted as a Farm to Market Road, to help and he will be glad to go to Austin with them/get the project started.

Commissioner Eldridge Ellison made a motion, seconded by Commissioner Billy McGee to transfer \$3,000.00 from Prct. # 3 to Prct. # 1 to repay money he had borrowed some time ago. Motion carried.

Judge Royce Smith reported to the court that he has received no estimate for repairs on the Toole Building.


There being no further business, Commissioner Billy McGee made a motion the meeting adjourn. Commissioner Chester Cox seconded the motion, and all voted for. Meeting adjourned.

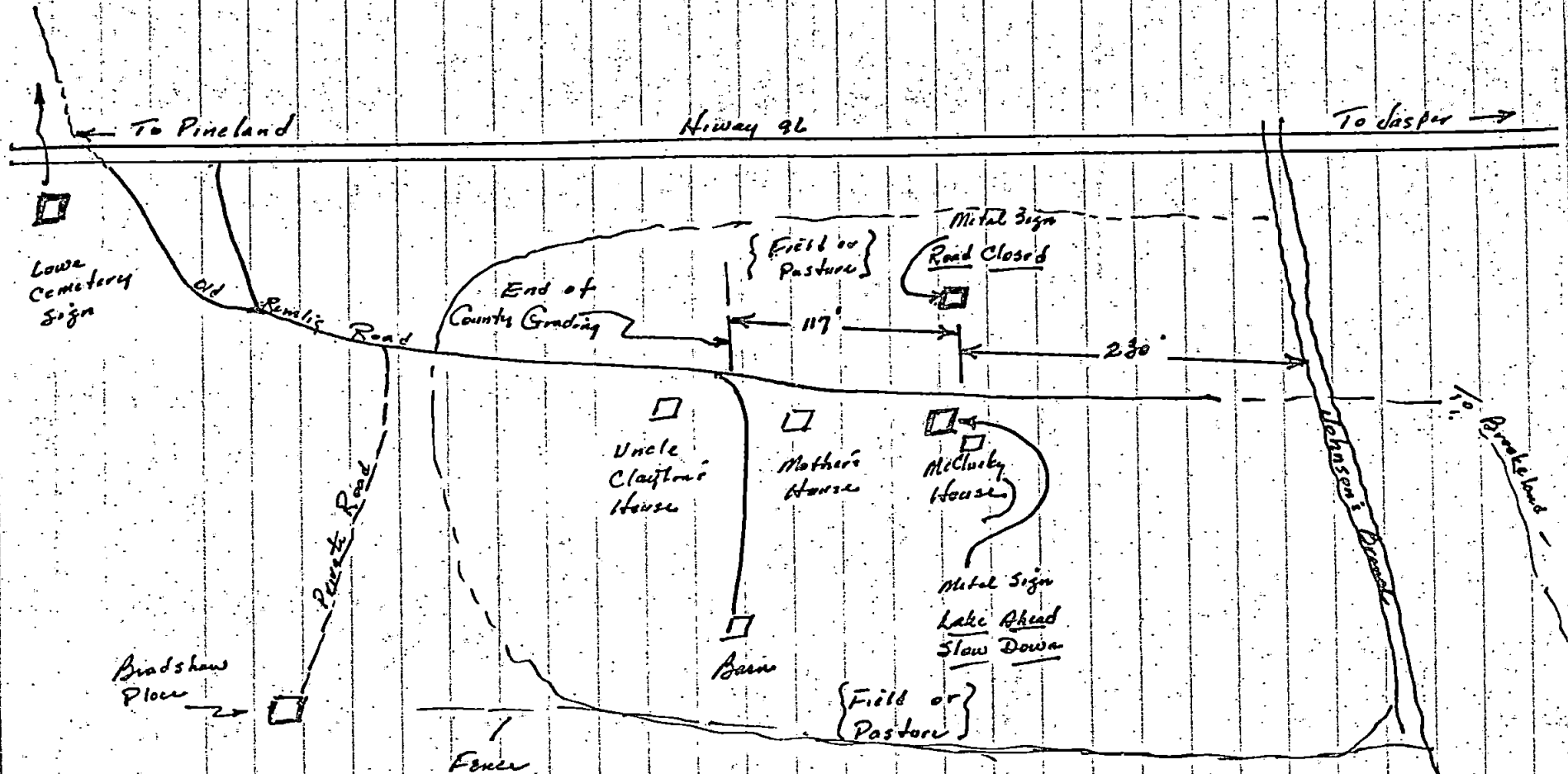
