The meeting was called to order by Judge Royce Smith.

This meeting was called with the Texas Highway Department to discuss which Sabine County Roads and bridges would be included in proposed improvement projects for 1987-1988. In the Off System Bridge Program, the Federal Government pays 80%, and the County Government pays 20%. They are now in the process of building an Off System Bridge on Six Mile Creek on the Scrapping Valley Road in Prot. # 2. The Farm to Market Program is financed with State money, with the Commissioners recommending roads to become Farm to Market Roads.

These qualifications are decided in three ways:

- 1. To improve existing Farm to Market Roads
- 2. To extend existing Farm to Market Roads
- 3. To build new Farm to Market Roads that will most benefit the people by serving a school bus route or a mail route, or high traffic route.

Highway officials Jeal. Beard, Bob Walker, Walter Hermsberger, and Morgan Prince are responsible with meeting with County Commissioners in our nine county district.

Commissioner Billy J. McGee made a motion that the county present two roads,

Pleasure Bend and El Camino Bay Roads for consideration under the Farm to Market

Program, with Commissioner Eldridge Ellison seconding. All voted for. Commissioner

Chester Cox made a motion that they present three bridges; the Springhill Road

Bridge, the Vickers Road Bridge, and the Cooper Road Bridge. Commissioner

R. E. Smith seconded the motion, and all voted for. Mr. Hernsberger will

prepare estimates for all three bridges, and turn in to State for approval.

The County Line Road and Shawnee Shores Road, both in Prct. # 2, already have petitions in Austin for Farm to Market Roads. Mr. John Letney, a land owner of Sam Rayburn Estates asked if it would be worth while for residents of Sam Rayburn Estates to go to Austin with their request that the County Line Road be made a Farm to Market Road since they were not one of the roads that was included in the roads for 1987-1988. Mr. Beard said that since this road runs between San Augustine and Sabine Counties, it would be good that representatives from both counties go to Austin and meet with the Commission with their facts.

Commissioner BillyJ. McGee made motion, seconded by Commissioner R. E. Smith that meeting adjourn. Motion carried.
