

The Honorable Commissioners' Court met in a regular session Monday, March 23, 1987, at 8:30 A. M., with the following members present:

Meeting was called to order by Judge Smith; Brother Clarence Howell led the opening prayer.

Minutes of the last meeting were read by Nadine Gary, County Clerk. Commissioner Eldridge Ellison made motion, seconded by Commissioner R. E. Smith, to approve reading of minutes. All voted in favor.

Mr. Turner with the Sabine County Appraisal Board, met with the Court and explained the present method of electing Board members for the Appraisal Board. The present system is based on tax levies rather than on the appraisal process which is best served by representation from all tax units. The Texas Property Tax Code provides for changing the selection method by a three-quarter vote of the taxing units in the district. He asked for a resolution changing the method of selection of directors of the Sabine County Appraisal Board.

Commissioner Cox made motion, seconded by Commissioner McGee, that proposed change in Central Appraisal Board be tabled until later. Motion carried.

Commissioner Chester Cox made motion, seconded by Commissioner Ellison to accept the closing of road to P. H. McGown houseplace in Precinct 4. All voted for.

Reginald Longlois with Sabine Satellite Electronics, Inc., met with the Court concerning Cable T V in Beechwood 1, 2, and 3, and Six Mile and Lowes Creek area. He explained there must be at least 40 houses per mile before Cable T V can be installed. Discussion from the floor followed. Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith that County Attorney Fortson do research into installing Cable T V, and report to the Court at next regular meeting. Motion carried.

After reviewing of County Bills, Commissioner R. E. Smith made motion, seconded by Commissioner Eldridge Ellison, to approve payment. Motion carried.

Tax Assessor-Collector Diane Husband reported that she had completed a Course in #325 Property Tax Law in Austin, on February 7, 1987. Her certificate was presented to the Court. Commissioner Cox made motion, seconded by Commissioner McGee, to approve the certificate. Motion carried.

Judge Smith explained to the Court that the County is now using the printed cards for County Jury Summons. He expressed his desire that each Juror summoned bring his card with him when he reports. In this way we hope to improve our Jury selections.

Commissioner Billy McGee made a motion, seconded by Commissioner R. E. Smith, that the Court pass a Resolution to support H.B. 787, (Trucking Deregulation Legislation,) in the State of Texas. Support Resolution shall be mailed to Representative Billy Clemons and Senator Roy Blake. Motion carried. See exhibit.

Commissioner Cox presented the Court with a letter Attorney Beth Brice wrote Attorney John Seale concerning the setting of a time for the Cleanup of Mrs. Neal's property, in connection with a District Court Case styled:





