The Texas Property Tax Code provides for changing the selection method by a threequarter vote of the taxing units in the district. He asked for a resolution changing the method of selection of directors of the Sabine County Appraisal Board.

Commissioner Cox made motion, seconded by Commissioner McGee, that proposed change in Central Appraisal Board be tabled untilllater. Motion carried.

Commissioner Chester Cox made motion, seconded by Commissioner Ellison to accept the closing of road to P. H. McGown houseplace in Precinct 4. All voted for.

Reginald Longlois with Sabine Satellite Electronics, Inc., met with the Court concerning Cable T V in Beechwood 1, 2, and 3, and Six Mile and Lowes Creek area. He explained there must be at least 40 houses per mile before Cable T V can be installed. Discussion from the floor followed. Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith that County Attorney Fortson do research into installing Cable T V, and report to the Court at next regular meeting. Motion carried.

After reviewing of County Bills, Commissioner R. E. Smith made motion, seconded by Commissioner Eldridge Ellison, to approve payment. Motion carried.

Tax Assessor-Collector Diane Husband reported that she had completed a Course in #325 Property Tax Law in Austin, on February 7, 1987. Her certificate was presented to the Court. Commissioner Cox made motion, seconded by Commissioner McGee, to approve the certificate. Motion carried.
