

On Monday, April 13, 1987, the Honorable Commissioners' Court met in a Regular session with the following members present:

Meeting was called to order by Judge Smith. Opening prayer was led by Brother Clarence Howell.

Minutes of the last meeting were read by Nadine Gary, County Clerk. Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith, to approve reading of minutes. All voted for.

Monthly bills were inspected and made ready for payment. Commissioner Eldridge Ellison made motion, seconded by Commissioner Chester Cox, to approve payment of bills. Motion carried.

The Sabine County Commissioners' Court was presented a copy of a petition opposing the licensing or establishment of the Elzie Wright Ministries, Inc. Emotional Treatment Center in Pineland, Texas. The petition is on file.

The following reports were presented for review: Treasurer's report, County Clerk's report, District Clerk's report, Tax Assessor-Collector report, also, J. P., Prct. 1, Mike Carmichael's report for J.P., Prct. # 5. Commissioner R. E. Smith made motion, seconded by Commissioner Eldridge Ellison, to approve reports. All voted in favor.

Elwood Gibbs, Director of Rebel Ridge Development & Control Committee, met with the c concerning roads in Rebel Ridge. Commissioner R. E. Smith made motion, seconded by Commissioner Billy McGee, stating that Sabine County has no responsibility for maintaing streets in Rebel Ridge Subdivision, except for 100 feet of short spur east from the Nazarene Church to junction of black top. Motion carried.

David Lafitte, with East Texas Cable T.V. in Newton, met with the Court requesting to bid on installing Cable T V in Beechwood 1, 2, and 3, and the Six Mile area. He stated that he serves Newton, Kirbyville, and Huntington. Their basic rate is \$11.00 per month. The Court asked for written proposals from both East Texas Cable T V, and Sabine Satellite Electronics, Inc. showing time proposals, rates, service rendered, these proposals to be presented April 27, 1987. Commissioner Billy McGee made <sup>this</sup> motion, seconded by Commissioner R. E. Smith, Motion carried.

Commissioner Billy McGee presented a letter from T. O. Bell stating that the road 3 miles south of Sam Rayburn due East to T. O. Bell's property be

known as "J. R. Bell Road". Commissioner McGee made motion, seconded by Commissioner Eldridge Ellison, to accept this name. Motion carried.

On behalf of the Public Responsibility Committee of Deep East Texas MHR, the name of Ms. Claudine Buckner of Center/<sup>was named</sup> to replace Ms. Margo Scherzer, who has served the maximum of years allowed, was presented to the Court for their approval. Commissioner R. E. Smith made motion, seconded by Commissioner Eldridge Ellison to approve this motion. All voted for.

Nadine Gary, County Clerk, asked the Court to set new Probate filing fees for the County, effective immediately. The filing fees have been \$45.00 to cover any Probate proceedings for the first year. To this \$45.00 Mrs Gary asked to add a \$5.00 sheriff fee, \$5.00 Law Library, and \$2.00 for each Letters Testamentary, Letter of Administration, or Letter of Guardianship. This makes a total fee of \$57.00. One letter is included in this price, and after that, there is an additional fee of \$2.00 each. Commissioner Billy McGee made a motion, seconded by Commissioner R. E. Smith. All voted for.

Ercil Langham with Gulf States Underwriters of Louisiana, Inc. met with the Court concerning the renewing of the County's Health Insurance contract. This was the only bid we received for the year 1987-1988. County Attorney, Herbert Fortson asked for a financial statement from them, and also informed him that he must show proof in writing from the State Board of Insurance in Austin that this company is licensed in the State of Texas. Since he did not have this proof, Commissioner Chester CoX made motion, seconded by Commissioner Billy J. McGee that this be tabled until April 27, 1987. Motion carried.

Nadine Gary, County Clerk, asked for temporary help in the Clerk's office, since Dawn Procell, one of her deputies, went to work for the County Attorney and District Clerk. The Court refused her request at this time, stating there was no money, and that Dawn would also be helping in her office.

Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith, to advertise for bids for a Sheriff Department vehicle, Police Package 1987. Trade-in is a 1984 Ford, and can be seen at the Sheriff Department. Bids will be opened at the regular meeting April 27, 1987. Motion carried.




Commissioner Billy McGee made motion, seconded by Commissioner Eldridge Ellison, that the meeting adjourn. Motion carried.


