

On Friday, May 22, the Honorable Commissioners Court met in a Regular session at 8:30 A. M., with the following members present:

Meeting was called to order by Judge Royce Smith; Judge Smith also led the opening prayer.

Minutes of the last meeting were read by County Clerk, Nadine Gary. Commissioner R. E. Smith made motion, seconded by Commissioner Eldridge Ellison, to approve the minutes. All voted for.

Monthly bills were inspected by the Court, and made ready for payment. Judge Smith presented a bill from George Booth, former J. P. of Precinct 2, outlining expenditures made by him while he was in office. These bills included expenses to J. P. School in Austin, 3 rolls postage stamps, phone calls, and 25 inquests made. (See attached exhibit) It was reported he had been audited, and his books cleared. Commissioner Chester/Cox made motion, seconded by Commissioner Billy McGee, to reimburse him for his expenses. Motion carried. Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith, to approve payment of the other bills. All voted for.

Neil Beall and Carl Beall presented a plat of Waterwood Subdivision to the Court for approval. Commissioner Billy McGee made a motion to accept the plat, with Commissioner Eldridge Ellison seconding. All voted for.

Commissioner Billy McGee made a motion, seconded by Commissioner Chester Cox to call an election to impose a sales and use tax of one-half of one percent to be used to reduce the county property tax rate. Motion carried. Judge Smith explained that each dollar raised by the new tax would decrease the County Tax one dollar. This election will be held the second Saturday in August, which is August 8, and will become effective in 1988.

Due to the absence of County Attorney Fortson, the discussion of repairs to the Toole building for a County Court room was postponed until a later date. Judge Smith informed the Court that American Legion Post 197 had offered the County the chance to rent their new building for \$100.00 per month, plus utilities. This building should be ready within 90 days. Commissioner McGee said this may be better than constructing a new building, or restoring an old one. The Court agreed to place the Legion's proposal on the June 8th agenda.

Judge Smith advised the Court he has not received any information from the authorities about the garbage disposal area planned for the Brookeland area.


Commissioner Billy McGee informed the Court the County has started their work on the road to Robert Earl Smith's Green Acres. His men have drug the ditches and cleared the access roads. According to the agreement with the U. S. Forest Service, they will start hauling gravel on the road Tuesday Morning.


Commissioner Cox discussed a petition to close .3 of a mile of road located between Pig Pratt's house and Hwy. 103 near Ben Payne Curve. This petition will not be presented until more property owners have signed.

Judge Smith informed the court that Sabine County Commissioners' Court will host the North and East Texas Judges Meeting which is scheduled for June 3, 4, and 5th in Lufkin.



Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith that meeting adjourn. All voted for; meeting adjourned.


