On Monday, June 8, 1987, the Honorable Commissioners' Court met in a Regular session with the following members present:

The meeting was called to order by Judge Smith, with Brother Clarence Howell leading the opening prayer.

Minutes of the last meeting were read by Nadine Gary, County Clerk. Commissioner Chester Cox made motion, seconded by Commissioner Billy Joe McGee, to approve the minutes. All voted in favor.

The monthly bills were made ready for payment. After inspection, Commissioner McGee made motion, seconded by Commissioner Smith to approve payment. Motion carried.

The following fee reports were given, and approved: County Tax Assessor-Collector, County Clerk, District Clerk, and County Treasurer. Diane Husband, Tax Collector, reported that 91% of the 1986 taxes have been collected. This leaves approximately \$60,000.00 not collected. Commissioner R. E. Smith made motion, seconded by Commissioner Billy J. McGee to approve reports. Motion carried.

In the discussion concerning the temporary County Court room, Commissioner McGee informed the court that County Attorney Fortson said this would not be necessary at this time, since our Court was going on so well.

Alton Carlson, a resident of Toledo Village, met with the court concerning roads in his subdivision. He asked if these were County Roads, or if the County would provide trucks to haul asphalt into the subdivision, and let the residents do the work on the roads when necessary. Commissioner McGee answered that this road had never been accepted as a County Road, but was accepted as a public road when the plat was approved. He also added that if this road was a school bus route, hexcanxpxexide he can provide a truck to haul materials when needed. Mr. Carlson stated that this road is a school bus route.

Michael DeFee met with the court asking the Court to approve his plat to Oak Ridge Subdivision. Upon the motion by Commissioner McGee, seconded by Commissioner Smith, the court approved this plat.

Roy Chance, a resident off Hwy. 87 South met with the court requesting that a 15 mile per hour speed limit sigh be posted on his road. Commissioner Smith said he will widen the road, and help in any way he can, but he does not think a sign will work, and it may not be legal. He will contact the County Attorney concerning this.

Forest Perkins, a resident on County Line Road in Prct. #2, met with the Court thanking them for their support in Austin to help them obtain a Farm to Market Road. He also asked for permission to name a portion of road in this area. Commissioner/said he thinks this road is in San Augustine County, but if it is in Sabine County, he has his permission. 6 6

Although the appointment of Election Judges was on the agenda, this was posponed until the next regular meeting, which is June 22. Also, there was some discussion concerning the County Sales and Use Tax Election. This will be discussed further at our next meeting.

There was some discussion on the Budget for 1987/1988. Upon a motion by Commissioner McGee, seconded by Commissioner Cox, the Court voted that the Budget be listed as the last item on each agenda at regular meetings. All voted for.

Judge Smith informed the Court that all employees having outstanding bills due from Gulf States Underwriters of Louisiana, Inc. should bring them in so they can be given to the County Attorney at one time for collection.

Commissioner McGee said he had received a check for \$500.00 for a 1975 Dodge Dump Truck he had advertised for sale. This check was from Richmond's Garage, and Commissioner McGee mademotion, seconded by Commissioner Smith to accept this check. Motion carried.

Judge Smith informed the Court that he had attended school at College Station Feb. 24thru 26, and County Clerk Nadine Gary and District Clerk, Tanya Walker attended the County and District Clerk's School at College Station March 17 thru March 19. Also, the County Treasurer, Ollie Faye Sparks attended the school April 20 thru 23rd. Judge Smith asked the Court to approve their certificates as a matter of record. Commissioner Smith made motion, seconded by Commissioner McGee to approve these certificates. All voted for.

Judge Smith asked for a 5 minute recess before hearing the Audit report.

Court re-convened at 10:00 o'clock for the Audit report. Carolyn Rhodes, with Crowell and Rhodes informed the Court that her firm had examined the statements of assets, liabilities, and fund balances of various funds, and the cash receipts and disburshments of Sabine County for the year ending September 30, 1986. In their report dated May 1, 1987, they determined that there were no irregularities in the County records and that the County has complied with all requirements. This report also included a list of comments and suggestions which would be helpful in improving the overall operation of the County. The Audit report is on file in the County Clerk's office. Commissioner McGee made motion, seconded by Commissioner Ellison to approve the Audit report. Motion carried.

Commissioner Billy Joe McGee made motion to pay \$10,000.00 on the \$57,500.00 Time Warrant he has at First State Bank. This motion was seconded by Commissioner R. E. Smith. All voted in favor.

Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith that meeting adjourn. Motion carried.
