

On Monday, July 27, 1987, the Honorable Commissioners Court met in a regular session at 8:30 A. M., with the following members present:

Due to the illness of his mother, Judge Smith was late getting to the meeting; so Commissioner McGee called the meeting to order, with Brother Clarence Howell leading the opening prayer.

After the reading of the minutes of the last meeting, Commissioner Cox made a motion, seconded by Commissioner Ellison to approve the minutes. All voted in favor.

Ray Meleton with Temple Eastex met with the court concerning a strip of road between Hwy 330 and Hwy. 87 near Geneva in Prct. # 4. Commissioner Cox reported that although this road has been traveled by the public for years, it has never been county maintained. He asked how this could be declared a public road. Commissioner Cox said he had discussed this with County Attorney Fortson, and asked that this be tabled until the August 10 agenda. This road runs between Reeves creek and Bourghs Creek, leaving FM Road 330, traveling in an East direction.

Commissioner Cox also asked that the Road Easement on Lazy J Road again be tabled until our August 10 meeting, due to unfinished research. Freddie Keel met with the court concerning Sabine Investment, but asked that this also be continued until our next meeting.

Dough Damron, a resident of Rebel Ridge, met with the Court concerning mail delivery in his subdivision. The route now turns at the entrance to the subdivision, and he asked the court to accept the roads in the subdivision, so the mail can travel through. Commissioner Smith explained that if this is done, the boat ramps could also be used by the public. He asked if all residents would agree to this. Then Commissioner Smith made a motion, seconded by Commissioner McGee to ask our County Attorney to check the restrictions on the subdivision before taking action, and agreed to have this item again on our agenda August 10. All voted for.

Commissioner Billy McGee made motion, seconded by Commissioner R. E. Smith, to transfer \$12,948.23 from the General Fund to Revenue Sharing. Motion carried.

After inspection of County bills, Commissioner McGee made a motion, seconded by Commissioner Ellison to approve payment. Motion carried.


Commissioner McGee informed the Court that A resident
of Woodland Estates, contacted him concerning the rebuilding of his fence on right
of way on FM 2928. Motion was made by Commissioner Smith, seconded by Commissioner
McGee, for him to rebuild his fence, and present a bill to the Court for reimburse-
ment. Motion carried.


Commissioner R. E. Smith made motion, seconded by Commissioner McGee to advertise
~~ask~~ for bids on a front end Crawler Loader for Prct. # 1. This was seconded by
Commissioner Billy McGee. The trade in is a AC6G front end loader. All voted for.
Motion carried. Bid opening will be August 10, 1987, at 9:00 A. M.

After a 10 minute break, Court re-convened at 9:45 for the Budget session.
After some discussion, Commissioner Smith made a motion, seconded by Commissioner
Ellison, to review all line items, and adopt the budget at our August 10 meeting.
All voted in favor.


John W. Dean and Dr. Warren Founds, of Many, Louisiana, and Tommy Warren
of Beaumont, met with the court asking them to waive the agenda, and hear their
proposal for a recreation area in Sabine County. Commissioner Cox made a motion
seconded by Commissioner Smith to honor their request. All voted in favor. This
park will cover approximately 3,000 acres, and will employ approximately 3,000
people. They also informed the court that 10 flags flew over this area in the
1800's, making it a very historical area. This will be for family entertainment,
and a great boost to our County, but will need our court's support. They agreed
to help in any way possible. After a motion by Commissioner McGee, seconded by
Commissioner Smith, it was approved that Tom Beall, president of the Sabine County
Chamber of Commerce, Freddie Keel, a local real estate agent, and Ray Meleton,
with Temple Eastex, along with our Commissioners Court, and Mr. Dean, Dr. Founds,
and Mr. Warren will form a co-ordination committee to work together on this project.
Warren stated there will be two public hearings held within the next 30 to 60
days where they will be looking for input from the people of Sabine county.

Commissioner McGee made a motion, seconded by Commissioner Cox that meeting
adjourn. All voted for.


