
Meeting was called to order by Judge Smith, with Judge Smith also leading the opening prayer.


Commissioner Billy McGee made a motion, seconded by Commissioner Chester Cox, to approve this new tax rate. Motion carried.


There being no further business, Commissioner McGee made a motion, seconded by Commissioner Ellison, that meeting adjourn. All voted for.






