

Monday, September 28, 1987, the Honorable Commissioners' Court met in a regular session at 8:30 A. M., with the following members present:

Meeting was called to order by Judge Smith, with Judge Smith also leading the opening prayer.

After the reading of the minutes of the last meeting, Commissioner Cox made a motion, seconded by Commissioner Ellison, to approve the minutes. Motion carried.

Monthly bills were inspected and made ready for payment. Commissioner R. E. Smith made a motion, seconded by Commissioner Billy McGee, to approve payment. All voted for.

District Clerk, Tanya Walker, presented the Court with the request of a copy machine for use on the second and third floors. Although the purchase of this machine is included in her budget for 1987-1988, the Court did not approve. After some discussion, Commissioner Billy McGee stated that after the County and District Clerks have turned in the monies which has been held in their accounts for several years, there will then be money available for the machine. Both the county and District Clerk said they will turn their funds in as soon as possible.

County salaries for 1987-1988 were adjusted as follows:

Dispatchers at the jail are to be paid the same as the Chief Deputy in the Tax Office and Clerk's office. Elected officials and other county employees will receive a 5% increase, effective October 1, 1987. This is an increase in salary only, and there will be no change in the expense allowance.

Judge Smith excused himself to attend the opening of the new Pineland State Bank Hemphill Branch opening. Commissioner McGee took his place as acting Judge.

Commissioner McGee then explained to the Court that after contacting the Telephone Company concerning the installing of utility lines on County Right-of-Ways, he was informed that the Commissioners Court cannot have authority for utility lines, but the county must be notified before work is done.

County Chairman, Jesse Moody, met with the Court concerning voting places in Precinct 8 and 16. He is recommending changing the voting place in Precinct 8 from the County Line Community Center to the Geneva Baptist Church in Geneva. The reason for this change is the Community Center building is not suitable for holding the elections. There is no electricity, water, or bathrooms.

In Precinct 16, Mrs. L. A. Schulze, the Precinct Judge, turned in a letter of resignation; and since this precinct and precinct 15 are both so small, and close together, Mr. Moody and Commissioner Ellison want to combine the two voting places. Also, the voting place for precinct 16 has been in Mrs. Schulze's carport, which is not an acceptable place. This would eliminate Precinct 16. Commissioner Ellison also requested we move ~~move~~ Precinct 15 voting place at Strickland from Pine Hill Church to the new Pine Park Church, since it will be more centrally located.

After some discussion, Commissioner Ellison made a motion, seconded by Commissioner R. E. Smith, that these changes be made. All voted for.

Commissioner R. E. Smith made a motion, seconded by Commissioner Eldridge Ellison, to issue a Time Warrant for \$19,832.00, payable to First State Bank in Hemphill to purchase a new FL7 Crawler Loader for Prct. # 1. Motion carried.

Ollie Faye Sparks, County Treasurer, met with the Court concerning dividing money in budget percentage wise.

Commissioner Smith made a motion, seconded by Commissioner Ellison, to approve the dividing of the money as stated. Motion carried.

Walter Diggles, with Texas Community Development Program, asked the Court to approve payment to Crowell and Rhodes \$2,053.07 for audit on grant. Commissioner Cox made a motion, seconded by Commissioner Ellison, to approve payment. Motion carried.

Bids for maintenance and repair on new jail roof will be opened at our meeting October 12, at 9:00.

Motion was made by Commissioner McGee, seconded by Commissioner Smith, to go into an Executive Session. Motion carried.

Regular session re-convened at 9:30. The Executive session concerned the judgment in District Court styled: Marsha Williams vs. County of Sabine. County Attorney Fortson reported the judgement calls for \$4,893.75 plus \$783.00 interest, making a total of \$5,676.75. No action was taken at this time.

Commissioner McGee made a motion, seconded by Commissioner Smith, that meeting adjourn. All voted for.


