Commissioner Eldridge Ellison made a motion, seconded by Commissioner Chester Cox, to approve payment of bills. All voted for.

County Extension Agent, John Toner, met with the Court concerning the purchase of a computer for his office. He explained that this combuter would cost \$4,500.00, with the county paying only \$ 1,310.00, and A. & M. paying the difference. Mr. Toner also explained he realises a computer is not included in his Budget for this year, but it will come out of next years budget. After some discussion about this, and "on line" cost, for a computer, his request was tabled until our next meeting, February 8th.

Commissioner Cox presented the following motion, seconded by Commissioner McGee, and asked the Court to accept it upon the advice of our attorney. The motion reads:

"A complete investigation is being conducted by State, Local and Federal Authorities. Upon advice from Council the resolution that was to be presented will be tabled for the time being pending legal advice since letigation is involved. But everyone can rest assured that Sabine County Commissioners Court will fully cooperate with all authorities in investigation and ask that it be tabled. My motion also includes a motion that the entire Commissioners Court pledge its cooperation in the investigation." All voted for.

Bill Beeson questioned the Commissioners about decals on their vehicles. He said he had seen some without decals, and did not know if they were County vehicles or not. Cimmissioner Cox said he had one trailer without decals, but he has not used it yet. Commissioner Ellison said all his have decals. Commissioner McGee said his Mack truck which was wrecked did not have decals for a while, but it does now. Commissioner Smith said he has one loader with no decals.

Mr. Beeson also asked about Marsha Williams' bond in connection with missing funds in the Tax Office. County Attorney Fortson answered there is no proof of malfeasance on the part of any employees in the Tax Office; therefore the bond is not collectable.

Commissioner McGee made a motion, seconded by Commissioner Smith, to waive the agenda for people present to make comments from the floor. Motion carried.

Nancy Cox said she understood the Sheriff had let them decide whether or not to pay the suspended deputies. She wanted to know their decision. Commissioner McGee answered it would soon be released to the press; possibly later that day.

Leanord Cassell and Bill Beeson commended the Court and law officials on how well all this had been handled, and how things had been kept under such good control. Carl Foster, another County resident, encouraged the Commissioners' Court and people in attendance to always think positive. He commented on our new jail in the County, and comfortable working conditions in the Court house. Also he stressed the fact that our county roads have improved in the last few years. レピン
