Meeting was called to order by Judge Royce C. Smith, with Brother Clarence Howell leading the opening prayer.

Minutes of the last meeting were read by County Clerk, Nadine Gary. It was stated that 85% of all taxes had been collected. Tax Collector, Diane Husband, said this should read 85% of taxes for 1987 have been collected. Commissioner Billy McGee made a motion, seconded by Commissioner R. E. Smith, to approve minutes after this correction has been made. All voted in favor.


Monthly bills were inspected for payment. Commissioner Smith made a motion, seconded by Commissioner Ellison, to approve payment. Motion carried.


Steve Gray, a resident of Precinct 2, met with the court concerning "Dump Picking" at County dumps. He stated that he and other residents of the County were unhappy about people going through their personal "trash." Not only is there a law against going through these landfills, but there is the chance of someone getting hurt by exploding cans or broken glass. The Court agreed to get our local paper to run an article concerning this problem.


Although a road in Precinct 4 was on the agenda, Commissioner Cox asked that this be discussed at our next meeting.

Judge Smith informed the Court the Deep East Texas County Judges and Commissioners will meet in Diboll at the Diboll Community Center Wednesday at 11:00 A. M. He also stated there is a bill introduced to purchase or trade more land in the Big Thicket Area on Village Creek in Harding County. Also the President has again put into the budget to change the U. S. Forest check from gross amount of sales to net amount. If this bill passes, it will cut our funds tremendously; it could be close to zero. Discussion from the floor followed.


There being no further business, Commissioner Smith made a motion, seconded by Commissioner Ellison, that meeting adjourn. Motion carried.


