

Monday, June 27, 1988, the Honorable Commissioners' Court met in regular session at 8:30 A. M. with the following members present:

Meeting was called to order by Judge Royce Smith. Brother Clarence Howell led the opening prayer.

Minutes of the last meeting were read and approved. Commissioner Eldridge Ellison made motion, seconded by Commissioner Billy McGee, to approve minutes. All voted for.

Monthly bills were inspected for payment. Commissioner McGee made a motion, seconded by Commissioner Smith, to approve payment of accounts and salaries. Motion carried.

Although Frank Rash, J. P., Prct. 1, was on the agenda, he was not present.

Mr. Laughlin from Springhill Subdivision in Prct. 2, met with the Court concerning roads in his subdivision. Mr. Laughlin explained he represents a group of Tax Payers in Springhill. He explained this subdivision was developed in 1969, and the recreation area was developed in 1970; and in 15 years residents had paid approximately \$70,000.00 in taxes. With this amount of taxes, he felt something should be done on the roads, which are in bad condition. He thinks 10 loads of good dirt and 6 hours of labor will help a lot. Martha Cain also addressed the Court explaining these roads will be a school bus route. Commissioner McGee explained these roads are inside the Subdivision, and have not been accepted by the County. He also agreed to meet with them to discuss this further when Court adjourns.

Mr. Felts from Prct. 2 was on the agenda concerning roads, but Commissioner McGee said this was settled out of Court, so he did not appear.

County finances were discussed. If any fund is in the red as much as \$20,000.00, additional money must be transferred from another fund. At this time Officers' Salary is in the red \$34,519.43. Tax Collector, Diane Husband stated that 92% of the taxes have been collected, and 6 law suits have been filed; so she does not anticipate much more money in this quarter. Also, there will be no County and District Clerk fees turned in until after July 1. Commissioner Smith made a motion, seconded by Commissioner Ellison, to transfer \$10,000.00 from General County, and \$5,000.00 from Right of Way to Officers' Salary to take care of this shortage. All voted for.

Early Bird had questions as to why the County was in the red? What had been done with the money? Commissioner McGee explained the County as a whole is not out of money. It is just not in the right category, and has to be transferred.

Commissioner Smith made a motion, seconded by Commissioner McGee to appoint Judge Royce Smith as Board Member to Deep East Texas Council of Government, DETCOG, for another year. Motion carried.


Sick leave and vacation pay for County employees was discussed. These options for sick leave were considered: Elected officials to have jurisdiction for the first 30 days, then get approval from the Court for an extended illness. Statement from the doctor stating employee is unable to return to work, and should the County continue to pay the Health Insurance after a 30 day illness if employee will be back in say, 6 months. No action was taken at this time, and will be an agenda item at our next meeting, July 11. At that time all recommendations will be considered.



Motion carried. This is a one time thing, only, and not a County policy.


Judge Smith gave a report on his trip to Washington. He met with all the Congressmen from our part of Texas, and does not anticipate much change in funds in the next twelve months.

Commissioner Cox then made a motion, seconded by Commissioner Smith, that meeting adjourn. All voted for.






