Meeting was called to order by County Judge, Royce C. Smith, with Brother Clarence Howell leading the opening prayer.  $m^2$  Kee

Motion was made by Commissioner Cox, Seconded by Commissioner Cox, to approve minutes of last meeting. Motion carried.

County bills were inspected and made ready for payment. Commissioner Smith made a motion, seconded by Commissioner McGee, to approve payment of accounts and salaries. Motion carried.

Commissioner McGee brought it to the Court's attention the budget should be amended. This will be an agenda item at our next meeting.

The court set the pay for the Election Judges and Clerks for the November 8 General Election. County Clerk, Nadine Gary, said last year payment was \$4.00 per hour, with the Judges receiving \$15.00 extra for picking up and returning supplies and ballots. After some discussion, the Court agreed to pay all judges and clerks \$5.00 per hour, with the judges receiving \$15.00 extra. Commissioner McGee made a motion, seconded by Commissioner Cox, to approve this payment. All voted for.

Sick leave, vacation, and termination was again discussed. The policy presented was reviewed, and the Court agreed to add to the termination part: "elected official or supervisor can terminate an employee immediately, with no pay, with just cause." After this change is made, the policy is adopted. Commissioner Cox made this motion, seconded by Commissioner McGee. Motion carried.

Albert C. Welch, J. P., Precinct 3, presented the Court with his letter of resignation to be effective July 31. Judge Welch said he had enjoyed working for the County, but his job with Deep East Texas Electric Co-op was now requiring more of his time. Commissioner McGee made a motion seconded by Commissioner Smith, to accept his resignation. Motion carried.

Welch then recommended Daniel R. Featherston to replace him as Justice of the Peace. This is for an unexpired term of two years. Commissioner McGee made a motion, seconded by Commissioner Smith, to approve his recommendation. All voted in favor. Mr. Featherston was in Court to accept, and his term will start August 1, 1988.

Although Early Bird was on the agenda, and was present, he did not speak at this meeting.

Commissioner McGee made a motion, seconded by Commissioner Ellison, that County Budget hearing requests be set at 9:30 A. M. on our regular Court days. All voted for.

A proposed budget for the Sabine County Appraisal District for January I, 1989 thru December 31, 1989, was presented to the court. Judge Smith informed the court there will be a budget hearing Monday, September 12, 1988, at 5:00 P. M. in the Hemphill Independent School District Tax Office.

Commissioner Cox presented a letter written to the Texas Department of Highways and Public Transportation. This letter states the Federal Co-op signs have been posted at all bridge locations. Commissioner Cox made a motion, seconded by Commissioner McGee, to approve this letter as a matter of record. Motion carried.

### SICKLEAVE

Sabine County reserves the right to pay only five consecutive days sickleave per year. (Year being defined as anniversary date to anniversary date of your employment).\* Your department head will determine and decide if more time is needed and within ten days make notification to commissioner's court.

Maternity leave will be handled on a case by case basis, the normal to be two weeks paid leave.

## VACATION

County policy requires each person to take a vacation each year. The following policy applies to all employees.

- (1) Employees are not entitled to a vacation (1) week until they have completed one year on the job.
- (2) All Employees with ten (10) on more years continous service are granted two (2) weeks.
- (3) All employees must take at least one (1) consecutive week of vacation during the calendar year.
- (4) The County will not pay for vacations not taken and they will not be carried over into the following year.
- (5) All vacations will be scheduled at the descretion of the department head and can be changed on one (1) weeks notice.

### TERMINATION

Sabine County reserves the right to receive a two week (2) written resigantion notice of an employy.

Elected officials will monitor their office and determine vacations, sickleave and terminations and only if necessary will they take it before commissioners court .
