Monday, August 22, 1988, the Honorable Commissioners' Court met in regular session, at 8:30 A. M., with the following members present:

Royce C. SmithCounty JudgeR. E. SmithCommissioner, Prct. # 1Billy J. McGeeCommissioner, Prct. # 2Eldridge EllisonCommissioner, Prct. # 3Chester Cox, Sr.Commissioner, Prct. # 4Nadine GaryClerk of the Court

Meeting was called to order by Judge Royce Smith. Brother Clarence Howell led the opening prayer.

Minutes of the last meeting were read by Clerk, Nadine Gary. Commissioner Cox made a motion, seconded by Commissioner McGee, to approve minutes. Motion carried.

After the inspection of monthly bills, Commissioner McGee made a motion, seconded by Commissioner Smith, to approve payment. Motion carried.

Commissioner McGee made a motion, seconded by Commissioner Ellison, to approve the Good Roads Amendment Resolution, Proposition 1. All voted for. This amendment will be on the November ballot.

Bill Vermeulen, Chairman for the Republician Party, presented questions concerning his recommendations for clerks and Poll Watchers in the November election. Questions asked were who he presents his recommendations to, and if the clerks and watchers are required to live in the precinct they work in. They are presented to the precinct judges, and must live in the precinct for the General Election, unless it has been pre-cleared with the Justice Department.

Mr. Vermeulen then asked questions concerning the Lakey Road in Prct. 2. Commissioner McGee said he was not on the agenda concerning this for this time, but it will be an agenda item at our next meeting.

Budget requests for 1988-1989 were discussed. The requests for additional full time help for the Sheriff's office, County Clerk and District Clerk was denied, and \$2,000.00 was allowed for each office for temporary help for the coming year. Mrs. Husband asked for \$1,000.00 for temporary help, and was allowed \$500.00. Also County Treasurer, Ollie Faye Sparks, was given \$250.00 for temporary help.

After these changes, the budget was adopted with an expected expenditure of \$1,609,037.00. Commissioner McGee made the motion, seconded by Commissioner Ellison, to adopt the proposed budget. All voted for.

Commissioner McGee then made a motion, seconded by Commissioner Cox, to amend the 1987-1988 budget as presented by County Treasurer Ollie Faye Sparks at our August 8th meeting. Motion carried.

Judge Smith called the Special Tax Rate Session to order. Motion was made by Commissioner R. E. Smith, seconded by Commissioner Billy McGee, to set the effective rate at \$.23. Mr. William Turner, a former Appraisal District member, and present Hospital Board member, and also Mr. W. C. Vickers, another County resident, had questions from the floor. These questions were answered by Commissioner McGee. After some discussion, all commissioners approved the motion to set the effective rate at \$.23.

Commissioner McGee then made a motion, seconded by Commissioner Smith, that meeting adjourn. Motion carried.
