

Monday, September 26, 1988, the Honorable Commissioners Court met in regular session at 8:30 A. M., with the following members present:

Meeting was called to order by Judge Royce Smith, with Brother Clarence Howell leading the opening prayer.

Minutes of the last meeting were read. The minutes stated the Community Development Block Grant meetings will be held in the Court room. Judge Smith requested this be changed to read they will be held in the District Courtroom. Commissioner Smith made a motion, seconded by Commissioner McGee, that the minutes be approved after this correction is made. Motion carried.

Judge Smith presented two certificates for Tax Assessor/Collector, Diane Husband. One is from Don Rowlett & Associates for a Fundamentals of Mathematics Course, the other is course #365, "Advanced Property Tax Collections." Mrs. Husband attended these classes in Austin, August 23-27. Commissioner Cox made a motion, seconded by Commissioner Smith, these certificates be accepted as a matter of record. Motion carried.

County bills and salary payroll checks were inspected. Commissioner Smith made a motion, seconded by Commissioner McGee, to approve payment. Motion carried.

James Jeansonne met with the court asking their approval for filing an amendment to the original plat of Dogwood Forest Estates II in Prct. 2. This amendment was filed to satisfy the State's requirements for septic systems. Commissioner McGee made a motion, seconded by Commissioner Smith, to accept this amendment. Motion carried.

Judge Smith informed the court that Senate Bill 715 requires the county Commissioners Court to set sheriff and constable fees before October 1st. of each year to be effective January 1 of the following year. County Clerk, Nadine Gary, stated all county fees for 1988 were \$40.00, and recommended the Court set the same for 1989. Commissioner Cox made a motion, seconded by Commissioner McGee, to accept her recommendation. Motion carried.

Commissioner Smith made a motion, seconded by Commissioner McGee, that Commissioners' Court set division of ad valorem tax money as follows: General- 34%, Jury-4%, Road and Bridge Tax-20%, Salary-36%, Jail-5%, and R&B 2 fuel adjustment-1%. Motion carried.

Commissioner Smith then made a motion, seconded by Commissioner Ellison, to divide the commissioners' money as follows: Precinct # 1-22%, Precinct # 2- 27%, precinct # 3-20%, and Precinct # 4-31%. Motion carried.

Mrs. Geneva Hignite from Sam Rayburn Estates in Prct. # 2, again met with the court concerning their roads. After some discussion, it was decided that all four commissioners, along with Temple and San Augusting County could work together one week on repairing the County Line Road. Commissioner McGee will contact Temple and San Augustine County Commissioners with this suggestion.

Don H. Pippin, Sr. was on the agenda concerning a salary deduction Hospital Plan, but was not present.

Judge Smith ask the commissioners Court to recognize the Proclamation calling for an election to be held November 8, 1988, as a matter of record. Commissioner Smith made a motion, seconded by Commissioner McGee, to recognize this Proclamation. Motion carried.

Commissioner R. E. Smith made a motion, seconded by Commissioner McGee, that Commissioner Smith pay off his Time Warrant in the amount of \$19,832.00. All voted for. The interest on this amount is \$1,186.65, so the pay off is \$21,018.65, to be paid out of Precinct # 1.

Commissioner McGee made a motion, seconded by Commissioner Smith, meeting adjourn. Motion carried.


I dropped by your office Thursday, 9/15/88, and visited with Dawn regarding our National Association of Counties program called Deferred Compensation. I represent 21 counties in Southeast Texas, and all of them are pleased with our supplementary retirement program. It works like an IRA, but you can shelter \$7,500 per year from taxes.

We have another plan that is called a Cafeteria Plan, which was passed by congress to give local government employees a tax break on dependent health insurance, day care, and other medical expenses. My reason for coming by is to get a time from you that would be convenient to talk to your Commissioners Court about these two programs.

I have just recently set up Angelina County, and San Augustine County, and would recommend that you talk to Dan Jones, and Carol Vaughn at San Augustine. There is no cost to the County to offer these tax shelters to the employees. The net effect to Sabine County would give your employee's a raise, save the County Money, and offer you a tax free place to save money for retirement on a strictly voluntary basis. This is all I want to discuss with you.

If it is possible, I would like to be placed on your next agenda for the Commissioner's Court, and take about 15 minutes to discuss this. You could give Judge Fillyaw in Newton County a call since I have presented this to him. I look forward to meeting with you, and hopefully working with you in the future.


