Mrs. Sloan asked Commissioner McGee to assist her in taking measurements on this road.

Some commissioners had not completed their lists of County owned and operated vehicles they were compiling for our insurance Company.







Don Pippin was again on the agenda concerning deferred compensation for County employees, but did not attend the meeting.


