Meeting was called to order by Judge Royce Smith; Brother Clarence Howell led the opening prayer.

Minutes of the last meeting were read by County Clerk, Nadine Gary. Commissioner McGee made a motion, seconded by Commissioner Smith, to approve minutes. Motion carried.

After the inspection of County bills, Commissioner Smith made a motion, seconded by Commissioner Ellison, to approve the payment of accounts and salaries. Motion carried.

Tax Assessor/Collector, Diane Husband had asked the Court to approve raising the tax certificate fee from \$4.00 to \$10.00. Motion was made by Commissioner Smith, seconded by Commissioner McGee, to leave this fee at \$4.00. All voted for.



Commissioner McGee made a motion, seconded by Commissioner Ellison, to approve the Quarterly Report. Motion carried.



This causes problems when she files a claim. Judge Smith pointed out that Wilbert Bragg, J. P. # 2, had asked that he be taken off the group policy, but had wanted to be paid the premium amount. He had been refused. After some discussion, Commissioner McGee made a motion that if this meets the approval of the current carrier, we will drop Mrs. Husband from our group policy, but with no compensation for her. Commissioner Cox seconded the motion, and all voted for.

Judge Smith also informed the Court of action to be taken in Commissioners' Court in January and February terms. Among this is advertise for bids for County Depository and oil and gas for County vehicles; also select Salary Grievance committee members, and appoint County Historical Survey Committee. In January we will start taking bids for County Health Insurance.

There being no further business, Commissioner McGee made a motion, seconded by Commissioner Smith, that meeting adjourn. Motion carried.


